THINKS OUTLOOK GOOD

Blankenship's Greatest Trouble Will Be in Filling Places of Bush and Zamloch, According to "Hatbox" View of Existing Conditions.

The last number of Sporting News contains an article on Missoula's baseball prospects and inasmuch as the initials at the bottom are "F. T. J." it is reasonable to suppose that "Hatbox" Jones is responsible for the article. Frank takes the following view of the local baseball future: "Although the Union association hasn't shown a cheep of life since the death of President Licens, the Missoula club owners know the nature of the game and realize that it is bound to bloom in the spring and are going ahead in the work of signing a team for next season. Besides acting as a guide for other teams to pattern after in this respect, the local directors have been very busy in trying to bring about a meeting of the Union association to hasten 1913 arrangements.

Manager Cliff Blankenship has been busy since the season closed in combing the bushes down in California for new talent for the Highlanders the coming season, though all the local team has lost by sale or draft are two pitchers, an outfielder and an infielder. Blankenship has already signed 13 new men for 1913, and if any of them prove fast enough to supplant some of the holdovers from 1912, those supplanted will be used in trades or sold to other clubs. The new men include Morrow, Swenson, Peters, Carpenter and Hudoff, infielders; Wolter and O'Hara, outfielders; Navarro, Linn, Brooks and Smith, pitchers, and Moore, catcher. With three exceptions all these men are from California and are touted as very promising material. Wolter and O'Hara, the outfielders, are highly recommended as two of the best young players in California. Dick Moore, the catcher, is the same player that reported in 1912. He lacked experience at that time, but reports from the west are that he has developed into a grand young catcher.

Navarre Gets Another Chance. "W. H. Navarre" of Spokane, a pitcher, was here awhile at the close of the season, but as the race for the pennant was close, the management did not deem it wise to experiment on young pitchers. Navarre showed a lot of stuff in practice and Blankenship kept him in mind.

"The other players named are unknown quantities, but they are vouched for by Blankenship as worthy of a trial and will be seen on the training trip.

"Of the old men from last year's team remaining, there are Roberts, catcher; Coyne, Cochran and Druhot, pitchers; Carman, first base; Perrine, second base; Changnon, third base; and Bassy and Tobin, outfielders.

"The pitchers' position is giving Manager Blankenship most concern, for it will be hard to replace such sterling performers as Zamloch and Bush, who have been sold to Detroit and the Philadelphia Athletics. Rarely ever has any club in any league developed such a duo of pitchers as Zamloch and Bush, and their departure hits the team hard.

"Right field will have to be filled, as Warren was drafted by New Orleans, but Wolter, a brother of the outfielder with New York, is highly touted and O'Hara is said to be a grand performer. Pitcher Colie Druhot also may be turned into an outfielder, as he is a sweet hitter and can cover lots of ground.

"Six infielders have been signed in an effort to fill Oriet's place at shortstop and some are spoken of as good men. Daschbach, who was received in a trade for Oriet, will most likely be used in the outfield, but he can play a nice infield."

PATSY RICE IS DEAD AT HOME IN HELENA
Helena, Dec. 20.—(Special.)—"Patsy" Rice, trainer of race horses since the tolling day, died here today of typhoid pneumonia. He came to Helena in 1886 and has been a familiar figure on all the tracks in the northwest, has made this city his headquarters. It is asserted every horse he ever undertook to train developed into a winner. Among other animals handled by him were George Wakefield, Modicum, Primus, Buttons, Mikado, Bozeman and other favorites of the racing public in Montana.
Besides his wife, Mr. Rice is survived by a number of relatives in Norcross, Minn. He was born in 1827.

GONZAGA CALLS OFF INTEREST IN CLUB BASKETBALL TRIP

VACATION PERIOD MAKES IT NECESSARY FOR LOCAL TEAM TO CANCEL GAME.

OTHERS FOLLOW SUIT

Only Two Teams Willing to Play During Holiday Season and Spokane Boys Will Stay at Home—First Time Catholics Were to Leave Home.

Gonzaga university will not play basketball with the university this year, according to an article which appeared in a recent issue of the Spokane Chronicle. The Gonzaga students are not allowed to leave their school while it is in session and it would have been impossible for the local team to have met the Spokane boys during the vacation period, as practically everyone has left for home. The Chronicle's article follows:

"The first basket ball trip ever scheduled for a Gonzaga university team has been called off by Graduate Manager Maurice Meagher, as the games which were scheduled for the trip were canceled by the out-of-town managers, making it impossible for the local team to make the trip. Dates had been secured at Missoula, Butte, Billings, Kalispell and Anaconda, and the local team was to have left Spokane as soon as the holiday vacation opened, to be gone for 10 days. Owing to the fact that the vacation period was on at Missoula, Butte and Anaconda at the time the games were scheduled to be played, the out-of-town managers decided that it would be impossible to draw enough of a game with Gonzaga. No game was scheduled with the Catholics, and the dates were canceled.

"It was impossible to make the trip to play two teams only," said Manager Meagher this morning. "This was to have been the first out-of-town trip for a Gonzaga team, and I am more than sorry that the managers failed us after scheduling the games."

"Under the circumstances it was impossible for the team to make the trip at any other time than the holidays, as the boys could not be excused from classes."

Klebe Denies Story.
Manager Klebe denied yesterday the report emanating from Spokane that he had called off a game with Gonzaga. No game was scheduled with the Catholics, says the manager. Maurice Meagher, manager of the Gonzaga team, wrote to Klebe asking for a game, but no arrangements were made.

HE WANTS ONE-TENTH OF THE STOCK AND FAT SALARY BEFORE HE'LL ACCEPT JOB.

Former Manager of the Cubs Announces That Owner Farrell of the Yankees Must Come Across Handsomely—Will Direct From Bench.

HE SAYS SO HIMSELF

Los Angeles, Dec. 20.—Owner Frank Farrell of the New York Americans will have to make Frank Chance the offer of a tenth interest in the club and give him a fat salary before the former leader of the Chicago Nationals consents to become manager of that team. This was the statement made today by Chance when he discussed freely for the first time his views regarding the conditions under which he would return to baseball.

Unless he can be a part owner in a major league club he will remain on his orange ranch, which he sold yields him a profit of from \$6,000 to \$7,000 yearly.
"A salary of \$25,000 a year would not tempt me into the management of the New York Americans," said Chance. "They must give me a tenth interest or it will be the orange ranch for me."
Chance stated positively that he had no offer from Farrell stipulating a salary. He also said that he never would play ball again and that if he took the New York team he would manage it from the bench.

THROUGH AS A PLAYER.

New York, Dec. 20.—If Frank Chance is engaged as manager of the New York Americans he will manage the club from the bench. Chance himself is quoted as saying so by a friend in this city who received a letter from the former Chicago manager. Chance said in effect that he was through as a first baseman and did not want to play any more, but would manage from the bench as he did at Chicago last season, and part of the season before. "This report is a disappointment to New York fans, who had already been making a lineup with Chance at first and Chase at second. It is expected that Chance and President Farrell of the New York Americans will meet early in January to perfect negotiations.

TO THE SHIP.

Portsmouth, England, Dec. 20.—The arrangements have been completed for the transfer of the body of the late Ambassador Whitelaw Reid from the special train on which it is to be conveyed here from London to the cruiser Natal, which will take it to the United States.
Admiral Sir Hedworth Meux, the naval commander-in-chief here, with other high officers of the British navy and 250 bluejackets and marines, will be in attendance to receive the coffin on its arrival at the depot. Naval petty officers will act as coffin bearers to the warship, and during its passage Nelson's flagship, the Victory, will fire 12 minute guns.
Guards will be mounted and minute guns fired as the Natal leaves the harbor at 3.30 o'clock in the afternoon. All the ships in the harbor and the roads will fly the United States ensign at half-mast, and the warships will parade guards on the quarter-deck, which will salute as the ship passes.

IN PARIS.

Paris, Dec. 20.—A memorial service for the late Ambassador Whitelaw Reid was held tonight at St. Luke's chapel. The Rev. Isaac Van Winkle delivered an address.
Robert Woods Bliss, American charge d'affaires, and the other members of the embassy staff were present, as well as members of the American Art Students club, which was founded by Mrs. Whitelaw Reid.

M'CREEDIE TO SELL NORTHWESTERN FRANCHISE

OWNER OF CLUBS IN TWO WESTERN LEAGUES WILL DISPOSE OF ONE, HE SAYS.

NICK WILLIAMS MAY BUY

Manager of Pippine Declares Himself a Prospective Purchaser and Will Try to Secure Capital to Go Through With the Deal.

Portland, Dec. 20.—Judge W. W. McCreddie, owner of the Pacific Coast and Northwestern league baseball clubs of this city, announced today that the Northwestern league franchise was for sale. In making the announcement he stated that he took this action because he believed it for the best interests of baseball that the two clubs should be under separate ownership. The price fixed by the magnate is \$1, and a reasonable compensation for those basebal players who are under reserve to the Portland club.
Nick Williams, manager of the Portland Northwestern team, at once declared himself a prospective purchaser. He stated he believed he could secure necessary capital providing that the Coast league would grant permission to the Northwestern league to maintain a Portland team for a term of years.

The railroad company in securing the patent are charged as follows: "In addition to the secret and fraudulent purpose and intent of said Southern Pacific Railroad company and its officers and agents in inducing the issuance of said patent and the including therein of said mineral lands, it was also the secret and fraudulent purpose and intent of said Southern Pacific Railroad company and its officers and agents to conceal from this plaintiff the true facts in the premises more than six years had elapsed from the date of the issuance of said patent to the end that the plaintiff should be delayed in the institution of judicial proceedings to enforce the rights of the plaintiff in the premises and in the hope that when said plaintiff should ultimately discover said fraud the delay in the institution of said judicial proceedings might be pleaded in defense thereof.

"The aforesaid fraudulent inducement of the issuance of said patent was designed, executed and consummated in a clandestine and surreptitious manner. The said fraudulent scheme was of such a nature and was so executed and consummated as to be naturally self-concealing.

"For the purpose of enabling the defendant Southern Pacific Railroad company to enjoy the fruits of the aforesaid frauds and at the same time conceal from this plaintiff the true facts, on or about May 22, 1903, the defendant Southern Pacific Railroad company caused the Kern Trading & Oil company to be organized and since said date said Southern Pacific Railroad company, through the medium and in the name of said Kern Trading & Oil company has been engaged in extracting and selling large quantities of minerals from said mineral lands. The defendant Southern Pacific Railroad company at all times has owned and still owns all of the capital stock of the defendant Kern Trading & Oil company and the latter corporation has been and still is maintained by the defendant Southern Pacific Railroad company as a dummy corporation for the aforesaid purpose. The business of removing minerals has been conducted in the name of the Kern Trading & Oil company under some pretended lease or contract, but for the purpose of concealing the true facts in the premises said pretended lease or other contract has been withheld from the official court records and has otherwise been concealed from this plaintiff."

"The Southern Pacific Land company is also described as a dummy corporation having leased mineral lands to the various additional corporations and individuals named as co-defendants. Each of those defendants with the exception of the Central Trust company of New York and Homer S. King, is alleged to have extracted large quantities of minerals, particularly petroleum, from the lands.
