

SULZER SPLITS WITH BOSS MURPHY

NEW YORK GOVERNOR DECLARES HE WILL NOT BE DICTATED TO BY TAMMANY.

BREAK IS IRREVOCABLE

Executive Says He Put Matter Up to His Wife and She Told Him to Fight for Decency in the State—Avers He's Surrounded by Spies—Positively Refuses to Loot State.

Albany, N. Y., June 21.—Accusing Charles F. Murphy of being "behind a conspiracy to blacken my character because I refused to do his bidding," Governor Sulzer today gave in detail his version of his break with the Tammany chieftain. For more than an hour the governor sat in the executive chamber and told to the newspaper correspondents a story bitter in its denunciation of Tammany's leader and replete with allegations that Murphy had attempted to influence the executive's action in matters of legislation, appointments and removals from office.

"I listened to his propositions," said the governor, "but I refused to do what he wanted me to do, because, in my opinion, he was wrong."

Ideals Shattered.

"I came back to Albany a sad man because some of my ideals had been shattered. I talked it over with Mrs. Sulzer because I have few confidants. I know I am surrounded by spies."

A BIG ORE BODY.


TAFT TO GET LL. D.

HE WON'T STAND FOR IT

Is Not Permitted by Attorney General McReynolds to Proceed Against the Western Fuel Company, Charged With Weighing, and Against Socially-Prominent White-Slavers.

San Francisco, June 21.—John L. McNab, United States district attorney for the northern California district, announced today that he had telegraphed his resignation to Attorney General McReynolds and requested an immediate acceptance.

As his reason McNab assigned recent orders by the attorney general for postponement of prosecution of the Western Fuel company, charged with having perpetrated frauds in weighing coal imports, and the Digges-Cambetti so-called white-slavery cases. In a letter to Mr. McReynolds, May 20, McNab said that evidence in his hands showed that the Western Fuel company had defrauded the government of fully \$1,000,000 due on imports of coal.

A statement given out tonight by McNab said: "I have been ordered to stay the prosecution against Maury Digges and Drew Cambetti for white slavery and the prosecution of certain of the directors of the Western Fuel company for their part in a gigantic conspiracy to rob the revenue of the government. I have done what any man who prizes his honor more than his salary would do. I have told the president of the United States, for whom I have the profoundest regard, that I will not consent to remain United States district attorney for another hour under such conditions."

McNab was appointed to office by President Taft. McNab's resignation, the acceptance of which he requested by wire, is contained in a long telegram to President Wilson. McNab says in the message that he feels forced to resign because of orders from the attorney general to stay his hands in the prosecution of the Digges-Cambetti white-slave cases and the indictments against officials of the Western Fuel company. He stated he received orders by telegraph yesterday to postpone action indefinitely in these cases, and in spite of his protest and statement to the attorney general that efforts to tamper with government witnesses in the cases had been made.

Telegram to Wilson.

The following is the telegram of resignation: "June 20, 1913.—Woodrow Wilson, president of the United States, Washington, D. C.

"I have the honor to tender my resignation as United States attorney for the northern district of California, to take effect immediately. I am ordered by the attorney general, over my protest, to postpone until autumn the trials of Maury Digges and Drew Cambetti, indicted for a heinous crime which has ruined two girls and shocked the moral sense of the people of California, and this after I have advised the department of justice that attempts have been made to corrupt the government witnesses, and friends of the defendants are publicly boasting that the wealth and political prominence of the defendants' relatives will procure my hand to be stayed through influence at Washington. In these cases two girls were taken from cultured homes, bullied and going to a foreign state, were ruined and debauched by the defendants, who abandoned their wives and infants to commit the crime.

"On receipt of the attorney general's telegram I prepared my resignation to take effect at the conclusion of the trial of the Western Fuel directors and the J. C.
