CAN TIED TO FRED FOR LACK OF SENSE

MINISTER WILLIAMS IS RECALLED FROM HIS POST AT ATHENS IN A HURRY.

Washington, July 6.—Formal announcement of the resignation of George Fred Williams as minister to Greece and Montenegro was made late today at the state department.

President Wilson is expected to accept the resignation tomorrow, and close the brief and extraordinary career of Mr. Williams as a diplomat.

Out From Under. Washington, July 6.—President Wilson today notified the principal European powers that the United States disclaims responsibility for a statement regarding Albania attributed to George Fred Williams, American minister to Greece and Montenegro.

Not Diplomatic. London, July 6.—The Williams incident is receiving little notice in the British newspapers.

"We are not surprised that Mr. Williams has been asked to resign. Obviously he is a remarkable personality, but diplomacy is not his line.

ENGLAND'S EXPORTS SHOW GREAT INCREASE

UNDER NEW AMERICAN TARIFF WE ARE GETTING A BIGGER LOT OF BRITISH WARES.

Washington, July 6.—(Special)—From a report made by the United States consuls at Bradford, Eng., which in part is as follows, it will be seen that the exports of goods from that consular district to the United States are increasing in a phenomenal degree.

The main item in April was raw wool as follows: Class 1, \$1,788,989 pounds; second class, 725,348 pounds; and third class, 64,647 pounds.

In manufactures of wool, tops reached the highest point since the tariff amounted to \$61,033 pounds; value, \$16,852; wool yarn, \$139,725 (233,636 pounds); and mohair yarns \$52,614 (96,781 pounds).
