

REPUBLICANS GAIN MANY SEATS IN THE LOWER HOUSE EVANS AND STOUT PROBABLY ELECTED IN MONTANA

NAVAL BATTLE IS WON BY GERMANS

Their Fleets Attack the British Off Chile; Cruiser Is Sunk.

ANOTHER CRUISER IS BELIEVED LOST

Still a Third British Ship Is Bottled Up—It is Decisive Victory

Valparaiso, Chile, Nov. 3.—The German warships Gneisenau, Scharnhorst, Nürnberg, Leipzig and Dresden today attacked the British fleet off Coronel, Chile. The British cruiser Monmouth was sunk. The cruiser Good Hope was very badly damaged and as she was on fire, is supposed to have been lost.

Santiago, Chile, Nov. 3.—The British cruiser Glasgow is also reported to have been badly damaged in the naval battle of Coronel. The British losses in killed and drowned were very heavy.

FEDERAL SOLDIERS ORDERED INTO ARKANSAS

LABOR TROUBLES THERE RESULT IN USE OF TROOPS—UNIONS ARE FEARFUL

Washington, Nov. 3.—It has been decided to send federal troops into the Hartford valley, Ark., strike zone. Orders have been prepared at the war department.

From Fort Sheridan. Chicago, Nov. 3.—Four troops of the fifth United States cavalry at Fort Sheridan—A, B, C, and D—were packed and ready tonight to leave early tomorrow for Fort Smith, Ark., to maintain order in the Hartford valley coal strike district. Major Nathaniel E. McClure, who has been with the troops in the Colorado mine strike districts will be in command of the force.

The Trouble.

Fort Smith, Ark., Nov. 3.—I sincerely hope Secretary Garrison's actions will not make of Arkansas another Colorado.

This was the statement of E. A. Cunningham, president of district number 21, United Mine Workers of America, with jurisdiction over the miners in the Hartford valley strike zone, when told by the Associated Press at McAlester, Okla., of the decision of the secretary of war to send federal troops to Arkansas.

No outbreaks have occurred in the strike district since Saturday night. Federal Judge Youmans and United States Marshal Parker, said tonight they had not been officially notified by Washington officials that the federal troops had been ordered to Fort Smith. That the sending of federal troops is the only solution of enforcing the orders of Judge Youmans was the opinion reiterated by both officials.

R. B. Hull, special agent of the department of justice, who has been here several weeks making an investigation, said that following the battle and running off of special deputies and employees at Prairie Creek mines last Thursday and the forcible taking of prisoners from Deputy Marshal T. N. Black Saturday night, he had recommended to the department of justice the sending of federal troops.

SLOW COUNT IN WYOMING.

Cheyenne, Wyo., Nov. 3.—Only meager returns from Wyoming's state election have been received. Political leaders declared reports were too meager on which to base a prediction.

KAISER ABANDONS CAMPAIGN ON COAST SHIFTS BRUNT TO YPRES TRENCHES

HE HAS GONE TO FRONT TO GIVE MEN COMFORT OF PRESENCE—ALLIES WILL NOT ALLOW TURKEY TO DRAW OUT OF WAR

London, Nov. 3.—That the German army has abandoned its attempt to break its way along the Belgian coast to Calais is agreed by all the official reports tonight.

A combination of inundated country, the remnant of the Belgian army under King Albert and the activity of the British warships, seemingly all contributed toward ending the costly struggle.

A Berlin official report attributes the failure of the Germans entirely to the flooded state of the country, where the water in places is over a man's head; but it declares that the army of Emperor William withdrew in good order and without losses.

Brunt on Ypres. After nearly three weeks of desperate fighting the brunt of the attack has now shifted to the Ypres region, where the English army of Field Marshal Sir John French, reinforced by Indians and territorials, apparently must meet another onslaught.

To the scene of this contemplated battle, according to reports Emperor William has gone, to give encouragement to his men by his presence.

As to Turkey. A state of war exists between Turkey on the one side and Russia, Great Britain and Serbia on the other, yet the Ottoman government appears as a house divided against itself, one section seemingly being desirous of war while the conservatives are trying to smooth over the situation arising from the attacks upon Russian ports and ships by Turkish war vessels directed by German officers.

Russia apparently has welcomed the war and will not give the Turks a chance to draw back, while the British cruiser Minerva has smashed the Turkish base of operations against Egypt at the head of the Gulf of Akabah. The Turkish ambassador in London has as yet made no arrangements to leave and the embassy still maintains a conciliatory attitude.

WAR DEMANDED WITH UNITED STATES MEXICO WROTH, AND IT'S CRITICAL

Mexico City, Nov. 3.—When it became generally known today that the Washington government had failed to comply with the request of the Mexican foreign offices that the United States fix a definite date for the evacuation of Vera Cruz, Mexico, Scottish Rite Masons presented thousands of proclamations calling upon the citizens to arm themselves and drive the invading foreigners from the shores of Mexico.

INUNDATION AREAS ARE PUZZLING GERMANS

Water South of Nieuport as High as Man—Battle is Still Desperate.

Amsterdam, via London, Nov. 3.—The following official dispatch, issued in Berlin, has been received here:

A telegram from general headquarters, dated November 3, at noon, states that inundations south of Nieuport prevent all operations in this part of the country.

"The water in places is as high as a fullgrown man. Our troops have evacuated the inundated districts, without loss of men, horses or guns."

"Our attacks on Ypres are progressing. More than 2,300 men, mostly English, have been captured, and also several machine guns."

Losses Great. "West of Ypres severe fighting has taken place, with great losses on both sides, but the situation is unchanged. In the village fighting we lost several hundred in missing, and two cannon. Our attacks on the Aisne, east of Soissons, are successful, despite obstinate resistance. Our troops have occupied several strongly fortified positions beyond Chavonne and Sopre, capturing more than 1,000 French, three cannon and four machine guns."

"In the Vosges, near Markinch, a French attack was repulsed and our troops began a counter attack."

"In the east, the operations are still in a state of evolution and there has been no fighting," the statement concludes.

BATTLE IN OREGON IS LEANING TO REPUBLICANS

Portland, Ore., Nov. 3.—The election of James Withycombe, republican, as governor, and of three republican representatives, are indicated. Chamberlain, democrat, led in the early returns over Booth, republican, for senator.

The vote of state wide prohibition was running close in Multnomah county, with the "wets" leading. In the outlying counties returns showed the dries to be leading.

MULHALL SECURES HIS "VINDICATION"

Chicago, Nov. 3.—Returns indicate the election of James T. McDermott, democrat, who resigned from congress when the famous Mulhall charges involving him as congressman from the fourth Illinois district. When he resigned McDermott said that he would go before the people for "vindication."

JAMES R MANN SELECTED Chicago, Nov. 3.—Republicans in the new lower house of congress retain their old leader, James R. Mann. A majority of 8,000 is predicted. Congressman Mann was vigorously opposed by a faction of the women suffragists.

GERMANS SINK ONE BRITISH SUBMARINE

Flying From Fleet They Throw Out Mines and Tiny Craft Goes.

London, Nov. 3.—The British submarine D-5 was sunk in the North sea early this morning by a mine, which was thrown out by a German cruiser retreating before cruisers. To officers and to men of the submarine were saved.

A German squadron fired on the British gunboat Halcyon, which was patrolling, wounding one man.

German Dory Battle. Various naval movements were made, the report continues, as a result of which the Germans retreated rapidly and although shadowed by the light cruisers they could not be brought into sea action.

The rear-most German cruiser in her retirement threw out a number of mines and the submarine was sunk by one of these.

NEW YORK SWEPT BY REPUBLICANS WHITMAN WINS, WADSWORTH SENATOR

STATE AND LEGISLATIVE TICKET ALSO ELECTED BY BIG MAJORITIES—SULZER RUNS THIRD, LEADING DAVENPORT

New York, Nov. 3.—District Attorney Charles S. Whitman, republican, was elected governor of New York today by an estimated plurality of 110,000, over Martin H. Glynn, democrat, the incumbent.

William Sulzer, who was impeached and removed from office in the fall of 1912 running on the prohibition and American tickets, finished third, polling, it appears on the face of incomplete returns slightly more than 100,000 votes. Frederick M. Davenport, progressive, ran fourth with approximately 50,000 votes.

Wadsworth to Senate. James W. Wadsworth, republican, appears to have defeated James W. Gerard, democrat, for the United States senatorship by about 45,000. Bainbridge Colby, progressive, was third with a vote that probably will not exceed 50,000.

In 4,081 districts out of 5,661 in the state the votes for governor stood: Whitman, 529,336; Glynn 453,278; Sulzer, 50,500; Davenport, 37,963. In 2,625 districts out of the total of 5,661, the vote for senator stood: Wadsworth, 254,607; Gerard, 237,742; Colby, 29,602.

G. O. P. Sweeps State. At republican headquarters it was said that their entire state ticket and a majority of their candidates for both houses of the legislature had been elected.

Supporters of Governor Glynn had hoped that he would carry Greater New York by 105,000 and that Mr. Whitman would come down to Harlem with no more than a plurality of 75,000. These hopes soon were disappointed. Virtually complete returns from the city indicated that Glynn probably would have a plurality of between 50,000 and 60,000 here and that Whitman's up-state lead would be well upwards of 175,000.

Wadsworth polled a good vote in Greater New York, approximately two-fifths of the total number of districts giving Gerard a lead of only about 30,000 over his opponent. At the same time Wadsworth had a 50,000 lead in a little less than one-third of the up-state districts.

SWEEPING REPUBLICAN GAINS MARK ELECTION THROUGHOUT THE NATION

BUT DEMOCRATS STILL RETAIN CONTROL OF THE HOUSE—PENROSE WINS AND "UNCLE JOE" HAS BEEN RETURNED TO CONGRESS

New York, Nov. 3.—Sweeping republican gains throughout the country, which reached a climax in this state, by the overwhelming victory of Charles S. Whitman, for governor, and of James W. Wadsworth, to succeed Elihu Root in the United States senate, were indicated tonight in early returns of the general elections.

Heavy falling off of the progressive vote in many states, the return to congress of former Speaker Joseph G. Cannon, decisive republican gains in New York and Illinois, in the house membership and the overwhelming defeat of Representative A. Mitchell Palmer by Senator Blaes Penrose, in Pennsylvania, were features of the early returns. Democratic leaders, however, were pleased by a triumph in

Massachusetts, where former Representative Samuel W. McCall was defeated for the governorship by Governor Walsh.

Still Control Congress. Early returns indicated that the democrats would retain control of congress, with approximately no change in the senate majority, but by a decidedly reduced majority in the house. At a late hour results in Illinois, Indiana, California and Colorado as to the senatorship, are in doubt.

In Illinois, Roger C. Sullivan, who had the indorsement of most of the administration leaders, Secretary of State Bryan excepted, defeated by a large plurality Senator L. Y. Sher-

San Francisco, Nov. 3.—Scattering returns received from every section of California indicate a landslide for Hiram W. Johnson, progressive candidate for re-election. Every precinct gave Johnson a plurality over John D. Fredericks, republican, with John B. Curtin, democrat, far in the rear.

Meager returns for the United States senatorship race between James D. Phelan, democrat; J. R. Nolan, republican, and Francis J. Heney, progressive, showed a result so close that a forecast would be mere guesswork.

It was asserted at anti-prohibition headquarters here that prohibition had been defeated more than two to one.

Phoenix, Ariz., Nov. 3.—Governor Hunt has carried the state by a probable majority of 3,000 votes. The state will go dry by a small majority.

COUNTY POLL IS FULL OF SURPRISES

Ballots Scratched Very Generally in Voting in Missoula.

CANDIDATES ELECTED FROM EVERY TICKET

Whitaker Is Sheriff and Lentz Is Judge—The Result in Detail.

There has never been an election in Missoula county, especially one between presidential years, in which there was so much general interest as that of yesterday, the complete returns of which were not received up to the hour of going to press this morning. Business was practically suspended throughout the day and although there was no open violation of the corrupt practice act, there was much earnest conversation between small groups of men, and women, too, as they were vitally interested in the outcome of their earnest efforts to gain the ballot in Montana.

As predicted some days before election, there was much "scratching" of tickets. The count of the judges developed the fact that mighty few tickets were voted straight. There were some big surprises. The dope sheets were all upset except in a few instances. The only combination that worked out, according to the general belief was the Habington-McCarthy-Currie trio, elected county clerk and recorder, county treasurer, and assessor, respectively. Their majorities were even larger than anticipated. One of the surprises was the close race between Frank Nelson and G. F. Peterson for county commissioner. During the day Nelson's election had been generally conceded. Before midnight he had given up hopes, and the last returns, with but two small precincts to hear from, gave Peterson a lead of 77 votes, probably a safe majority. One of the other interesting races was between Marion, democrat, and Whitaker, socialist, for sheriff. That Whitaker

HENDERSON PLACED IN SHERIFF'S SEAT

SILVER BOW ELECTS LAW AND ORDER MAN AS SHERIFF—DEMOCRATS WIN REST

Butte, Nov. 3.—(Special.)—With the exception of Charles Henderson, republican candidate for sheriff, the returns late tonight indicate that democrats made a clean sweep in Silver Bow county, the republicans running second, the socialists third, and the progressives fourth. The falling off in the socialist strength was one of the surprises of the election.

One of the surprises was the remarkable strength shown by former socialist mayor, Lewis J. Duncan, for congress, the returns from 40 out of 68 giving him 2,049, far outstripping the rest of his ticket.

It is estimated that the democratic state candidates will go out of Silver Bow with from 800 to 1,000 votes to the good. Compensation has carried in Silver Bow, but the incomplete vote shows that the voters have been lukewarm towards suffrage, and the vote will about break even.

Silver Bow also is against consolidation, and the returns up to late tonight show that the Kiley boxing bill has 200 votes in its favor.

Henderson for sheriff, over whom one of the hardest fights was waged, is elected by probably a plurality of 200 over Driscoll, democrat, the former sheriff. Canning, democrat, for attorney is an easy winner.

ARIZONA DRY. Phoenix, Ariz., Nov. 3.—Governor Hunt has carried the state by a probable majority of 3,000 votes. The state will go dry by a small majority.
