GENERAL NEWS.

Doings Throughout the World and the Nation.

Items Taken From the Latest Telegraphic Reports on Subjects of Interest.

Last Friday 300 vigilantes in West Virginia gave some thieves their walking papers.

Judge H. J. Elliott who made the welcoming address to the president at Memphis last Saturday morning, died on the stand before the ceremonies were over.

In Chicago, last Sunday, Steven W. Rawson was shot by a son of his wife, aged 16. Rawson had accused his wife of adultery, and the boy acted through revenge.

At New York, last Monday morning, a fire in a building at No. 17 South street, occupied by J. G. Alport, wholesale grocer and ship chandler, caused damage to about \$100,000.

Surgeon General Hamilton received a telegram from Tampa, Florida, Tuesday morning, saying that there had been three new cases of fever, but no deaths since the last report.

Serious riots occurred at Gibraltar last Sunday between the Irish and English soldiers. Many rioters were injured. Several arrests have been made and the streets are guarded by patrols.

The Galveston, Harrisburg & San Antonio mail and express which left El Paso Friday evening was stopped four miles east of the city by three masked men. An alarm drove them off before securing anything.

Henry D. Little has published a fifteen column reiteration of his charges against Senator McPherson, of New Jersey, bargaining to secure the election of General Sewell as Senator in return for business favors.

Tuesday evening the Helena & Northern railroad was completed into Marysville. Work had been somewhat delayed by lack of material and for a day or two past by a terrific gale blowing down the gulch.

The Kent House, at Lakewood, on Chautauque lake, was totally destroyed by fire last week and the cottages damaged. The burned hotel was the finest on the lake, and the total loss will reach \$125,000; insurance, \$26,000.

A large fire broke out in the packing department of Adams & Co.'s glass works on Carson street, Pittsburgh, Pennsylvania, last Monday. The entire glass works plant and a row of tenements were destroyed. The loss is estimated at \$75,000.

The report of the bureau of statistics on the wool product will be issued shortly. It will estimate the wool clip this year at \$70,000,000, and the number of sheep in the country at 40,000,000, an increase of 5,000,000 since the last census.

Robert Neil's boarding house at Lake Edward, Quebec, was burned at midnight Tuesday. Three of the boarders, Thomas Landis, of Norton Mills, Vermont; William Buchanan, of Little River, and Geo. Scotton, of California, were burned to a crisp.

The great international encampment was placed in the hands of the receiver this morning. General Bently and other managers of the affair united in a petition to Judge Garnett this morning that a receiver be appointed, which was granted.

Sunday morning, at Albuquerque, N. M., a switchman from Illinois named Sullivan tried to connect a Miller draw-head with a common coupling. He was caught between the cars and crushed horribly, his life becoming extinct a few moments after the accident.

In Albuquerque, N. M., Saturday night, two Mexican boys were trying to clean a loaded shotgun. The charge exploded, scattering Roman Martinez's brains over the room. The victim, who was only 14 years old, presented a horrible sight, his head being blown from his body.

A crisis is approaching in the affairs of Corea, over which kingdom the emperor of China claims sovereignty. The independence of the Korean king in the appointment of five ministers plenipotentiary to represent him at the courts of other nations is resented by the Chinese.

An attempt was made last Saturday evening to rob the International & Great Northern passenger train near Spring Station, Texas, by two masked men. They boarded the engine and forced the engineer to stop the train, but the mail agent killed one with a shotgun and drove the other off.

Inter Mountain, 18th: E. L. Bonner came up from Deer Lodge last night. Mr. Bonner says the Bitter Root railroad will be finished in forty days.

The Enterprise says that they will resume work this week at \$3.50 per day, so it is probable that the coal vein has increased in size.

Nearly 1,500 feet of the Wickes tunnel is now bored, leaving some 5,000 feet yet to go. It will take just a bit another year to complete the tunnel. Of course, all other portions of the road will be completed much sooner.

Mr. E. P. H. Harrison has obtained the contract for the survey of the Crow reservation boundary, in accordance with the recent direction of the Interior department—on the north, from the Big Horn river to the eastern corner, and on the east from that corner to the Montana base line.

Billings Gazette: The Rocky Fork & Cooke City road is now being graded at the rate of one mile per day, and this rate is being increased by the arrival of men and teams from distant points. When Fortune & Skelton's full force get to work on this end of the road this amount of work per day will be doubled.

Independent: Delegate Toole believes the admission of Montana will be included in an omnibus bill, including also Dakota, New Mexico and Washington. Toole has been engaged in trying to secure direct mail service along the line of the new Montana extension of the Manitoba road to towns now supplied from Helena.

Inter Mountain: The street car track builders turned the corner at Park street into main Main this morning and are making their way steadily up the street. Ties are sunk beneath the surface every three or four feet, the rails are laid upon these, the space between is filled with three inches of planking, and the outside of the rails is protected by a plank ten inches wide and three inches thick.

The city council at a special meeting last Monday accepted the proposition from the gas company to light the streets of Butte. They are to put in 100 street lamps, or more, if the council desires, the burners to be 16 candle power, and the cost to be \$2.50 per month each. The Electric Light company has had a contract for furnishing thirteen 2,000-candle power arc lights, at \$20 per month each.

Independent: Surveyor-General Green's office is now crowded with mineral work, and an extra force is being employed upon it. The unusual rush in this class of work is in part due to the great increase of mining developments in the territory and in part to the fact that the end of each year produces an anxiety among mine owners to prove up their claims rather than take possible chances of the jumping season on the first of January.
