ORDER OF PUBLICATION

EMILIE DERRY vs ANTONIO DERRY Bennington County Court, December Term, 1916.

WHEREAS, Emilie Derry of Manchester, in the County of Bennington, in the State of Vermont, has this day filed in the office of the Clerk of the County Court for said County of Bennington, her libel for divorce against Antonio Derry, therein setting forth in substance that on the 25th day of February 1888, at Dorset, in said County of Bennington, she was lawfully joined in marriage to the said Antonio Derry; that during the coverture, she on her part, both faithfully kept the marriage covenant and performed all the duties appertaining thereto, but that the said libellee, on his part, the marriage covenant hath not kept but hath violated the same; for that the said libellee, though possessed of sufficient pecuniary and physical ability properly and suitably to provide for, maintain and support the said libellant, has, without cause, for many years grossly, wantonly and cruelly refused and neglected so to do; that said libellee has treated said libellant with intolerable severity, animosity between her and the said libellee may be dissolved and that the Court will grant her a Bill of Divorce. And whereas, it having been made to appear by satisfactory proof, by way of affidavit of the said libellant, Emilie Derry, this day filed in the office of the said County Clerk, that the said Antonio Derry is without this state in parts unknown to the said libellant and that she has made diligent inquiry and does not know where said libellee resides.

IT IS THEREUPON ORDERED, that notice of the pendency of this libel be given to the said libellee by publishing this order three weeks successively in the Manchester Journal, a newspaper published at Manchester in said County, the last publication to be at least six weeks previous to the commencement of said term of Court.

Whereupon the said Antonio Derry is notified to appear before the Bennington County Court, at the next stated term thereof, to be held at Bennington, within and for the County of Bennington, on the first Tuesday of December A. D. 1916, to show cause if any he have, why the prayer of said libellant should not be granted.
