High Court of Chancery,

The Complainant states

in his bill that the defendants Benjamin Gaither and Basil Gaither were seized in fee as tenants in common of a tract of land in Frederick County, called Hammond's Strife;—that being so seized, Basil executed a power of attorney to Benjamin authorizing him to sell his, the said Basil's interest in the said land, that afterwards the said Benjamin sold the said land to a certain William Gaither for the consideration of six hundred pounds which hath been since paid, that the said William hath assigned to the Complainant Henry Rape the bond executed by the said Benjamin for the conveyance of the said land: The Complainant now further states (and so appears to the Chancellor) that the defendants are non-residents of the state of Maryland, and therefore out of the reach of the process of this court.

It is therefore adjudged and ordered, that the Complainant procure a copy of this order to be inserted in the newspaper of Angell and Sullivan, and in the United States Gazette at least three weeks successively, before the twentieth day of May next; to the intent that the Defendants and all others, who may conceive themselves interested in the premises, may have notice to appear in this court, on or before the third Tuesday in September next, to shew cause wherefore a decree should not pass for vesting in the Complainant a complete legal title to the land aforesaid.

Nicholas Low, Rufus King, Herman Le Roy, James Watson, Richard Harrison, Abijah Hammond, and Cornelius Rey, of the city of New-York—Thomas Willing, Joseph Ball, Matthew McConnell and Andrew Bayard, of the city of Philadelphia—His Excellency Richard Howell, Esq. Elias Boudinot, General Elias Dayton, James Parker, John Bayard, Doctor Lewis Donnan, Samuel W. Stockton, Joshua M. Wallace, Joseph Bloomfield, and Eliza Boudinot, of New-Jersey, who offer the following Scheme of a Lottery, and pledge themselves to the public, that they will take every assurance and precaution in their power to have the Monies paid by the Managers, from time to time, as received, into the Banks at New-York and Philadelphia, to remain for the purpose of paying Prizes, which shall be immediately discharged by a check upon one of the Banks.

INFORMATION is hereby given to all the military invalids of the United States, that the sums to which they are entitled for six months of their annual pension, from the fourth day of September 1793, and which will become due on the 5th day of March 1794, will be paid on the said day by the Commissioners of the Loans within the states respectively, under the usual regulations.

Applications of executors and administrators must be accompanied with legal evidence of their respective offices, and also of the time the invalids died, whose pension they may claim.

STATE OF SOUTH-CAROLINA.

In the House of Representatives,

DECEMBER 21st, 1793.

WHEREAS the Commissioners of public Accounts, have reported, that they cannot proceed to the investigation of the Treasury Accounts, respecting special Indents, without knowing the outstanding amount thereof in circulation:—Therefore,

Resolved, That all holders of special Indents be directed, and required, on or before the first day of November next, to deliver the special Indents in their possession to one or other of the Commissioners of the Treasury, who are to give receipts for the same, and to report to the Commissioners on public accounts, on or before the tenth day of November next, the amount by them respectively received, and also to the Legislature, at their meeting in November next, and that all special Indents not rendered into the Treasury as above, on or before the first day of November next, shall be, and the same are hereby barred.

Resolved, That public notice of this resolution be given in the several Gazettes in this State, once every three weeks, until the first day of November next. And that the Delegates of this State in the Congress of the United States, be requested to cause this resolution to be published in one or more papers in the cities of Philadelphia and New-York, and that provision will be made for the expences attending such publication.

Ordered, That the resolution be sent to the Senate for their concurrence.
