STATE OF SOUTH-CAROLINA.

In the House of Representatives,

DECEMBER 21st, 1793.

WHEREAS the Commissioners of public Accounts, have reported, that they cannot proceed to the investigation of the Treasury Accounts, respecting special Indents, without knowing the outstanding amount thereof in circulation:—Therefore,

Resolved, That all holders of special Indents be directed, and required, on or before the first day of November next, to deliver the special Indents in their possession to one or other of the Commissioners of the Treasury, who are to give receipts for the same, and to report to the Commissioners on public accounts, on or before the tenth day of November next, the amount by them respectively received, and also to the Legislature, at their meeting in November next, and that all special Indents not rendered into the Treasury as above, on or before the first day of November next, shall be, and the same are hereby barred.

Resolved, That public notice of this resolution be given in the several Gazettes in this State, once every three weeks, until the first day of November next. And that the Delegates of this State in the Congress of the United States, be requested to cause this resolution to be published in one or more papers in the cities of Philadelphia and New-York, and that provision will be made for the expenses attending such publication.

Ordered, That the resolution be sent to the Senate for their concurrence.

The following memorial from Samuel Hopkins, was read in the House of Representatives of this Commonwealth, the 19th inst.

To the Speaker and Members of the Assembly of Pennsylvania:

THE Subscriber apprehends he has at great labour and expence much improved on the common mode of manufacturing pot and pearl ashes, for which improvement the United States have granted him, an exclusive right for a term of years. The advantages over the former is set forth by divers Certificates, one of which signed by David Rittenhouse, Doctor Rush and others, hath been published. By variety of improvements in the application of the principle, he apprehends he has so far simplify'd it, that at small expence it may be conducted by women or children, altho' larger the works greater the profits resulting in proportion. In a work that may cost about 12 dollars to be worked by a boy of 12 or 13 years old, with attention, may make 150 weight of pearl ashes, and with good house ashes at 9d per bushel, wood at 20s per cord; the pearl ashes so made when sold at the common price of 50s per hundred, leaves about 40s for his week's labour. The process is allowed to be easy and familiar, one of those small works is now standing at his house in Arch Street No. 43, and is free for inspection to any that inclines to visit it; he therefore wishes a suitable Committee may be appointed, one or more members of each County to examine the same, see some experiments performed, and should it be thought after every necessary examination, this improvement preferable to the former, and a general benefit to this State, in bringing forward this manufactory in which little heretofore have been done, he willing to relinquish his aforesaid right, as far as relates to Pennsylvania, for such a compensation as the merits of it may appear reasonable to desire.

A work that may cost about 300 dollars when compleat with 4 large boilers worked by 2 fires, 2 hands may make as much pearl ashes as common black salts, perhaps 18 or 20 cwt. per week, it may require about 7 cord of wood. The quantity made in a certain given time, will always depend on the attention of the workmen, the size of the furnace, the quality of the ashes, &c. &c.

The Committee appointed Feb. 25, last, on the memorial of Samuel Hopkins, made report, which was read as follows, viz:

The Committee to whom was refered the application of Samuel Hopkins to the Legislature, on the subject of an improvement discovered by him in the manufactory of pot and pearl ashes, beg leave to report—That they think favourably of the prayer of the said applicant, and are of opinion that it will be advantageous for the State to have the mode invented by him, rendered of general utility, by the purchase of his exclusive privilege in the discovery, which they understand may be effected on very moderate terms; they therefore recommend the following resolution:

Resolved, That a Committee be appointed to bring in a bill to grant the sum of £ to Samuel Hopkins, in reward of his discovery, and as a compensation for the surrender of his exclusive right to said improvement, within the limits of this commonwealth.

Henry Rape State of Maryland.

Benjamin Gaither High Court of Chancery,

and March 5th. 1794.

Basil Gaither

The Complainant states

in his bill that the defendants Benjamin Gaither and Basil Gaither were seized in fee as tenants in common of a tract of land in Frederick County, called Hammonds Strif;—that being so seized, Basil executed a power of attorney to Benjamin authorizing him to sell his, the said Basil's interest in the said land, that afterwards the said Benjamin sold the said land to a certain William Gaither for the consideration of six hundred pounds which hath been since paid, that the said William hath assigned to the Complainant Henry Rape the bond executed by the said Benjamin for the conveyance of the said land: The Complainant now further states (and so appears to the Chancellor) that the defendants are non-residents of the state of Maryland, and therefore out of the reach of the process of this court.

It is therefore adjudged and ordered, that the Complainant procure a copy of this order to be inserted in the newspaper of Angell and Sullivan, and in the United States Gazette at least three weeks successively, before the twentieth day of May next; to the intent that the Defendants and all others, who may conceive themselves interested in the premises, may have notice to appear in this court, on or before the third Tuesday in September next, to shew cause wherefore a decree should not pass for vesting in the Complainant a complete legal title to the land aforesaid.
