### PIRACY!

THE schooner DELIGHT, the property of Manuel Antonio Martin, of the Island of Bona Vista, was on the 18th of October last, while lying at anchor in the road of that Island, forcibly entered and carried off by JOHN DUNHAM, JOHN MURRAY, a man by the name of DODGE, and one other person, name unknown.—This vessel was sold to M. A. Martin, by William McNeill, who came to Bona Vista in her, from Madeira.—She was built in the county of Matthews, state of Virginia, and was registered at New-York, the 16th April, 1793.—Her name was printed on her stern—Her dimensions as follows: 56 feet 6 inches keel, 16 feet 6 inches beam, hold 6 feet 2 inches, her burthen 54 tons.

At the time of their entering the vessel, there was a black man on board by the name of Balthazer, whom they carried off with them. John Dunham was mate of the vessel under Capt. McNeill, prior to the sale of her, and the other persons were mariners. Dunham is a married man, and has a family at Nantucket.

The cargo of the vessel consisted of the following articles.—2 casks containing 74 pieces Linen; café Wine-Glasses; 1 bale containing 9 pieces Broadcloth; 1 do. 9 do. 79 pieces Cotton, (needle worked)—33 do. do inferior, 2 m ys of Salt; she had seven small arms and some pistols.

If any person can give any information of this vessel, or any part of the property, so that it can be recovered, or the offenders brought to justice, they are requested to inform Messrs. JOSEPH ANTHONY and SON, Philadelphia; MURRAY and MUMFORD, New-York; CLARK and NIGHTINGALE, Providence; or HEAD and AMORY, Boston.

FOREIGN INTELLIGENCE.

GENOA, Jan. 10.

The following picture will give those who are desirous of obtaining a just idea of the affairs of Genoa, which continue to be greatly embarrassed some information on that subject. The members of government, that is, the whole nobility are of course all aristocrats, some young men excepted. It would have been easy, especially after the capture of Toulon, to have induced the Republic to declare in favor of the combined powers. Government would have found no opposition from the class which you call commoners, nor from the people, for say what we will, the general interest of Genoa is to preserve its trade; that of guarding its property vested in the funds of France, is but a secondary motive; but, in consequence of the extreme violence of the English, the propensity of the second class who are rich and of the people who are not without energy, is entirely changed. This injustice has at length produced a spirit of independence. The recovery of Toulon, which would render an invasion of Genoa on the part of France more practicable, added to the just conduct of the French with respect to the Republic, has confirmed this change of sentiment, and neutrality at all events is to be maintained. As the government has no power except when it has the general voice in its favor, a revolution might be expected, were it to adopt a different conduct. Hence, the refusal of treating with Sir Gilbert Elliot at La Spezia.—The government dares not suffer the Genoese and the French to imagine it is inclined to abandon its neutrality. This, likewise, accounts for the effects which have been produced by the arduous negotiations of Mr. Drake and Lord Hood.

MADRID Jan. 20.

It should seem that the court of Spain interested in the re-establishment of the House of Bourbon ought to have found no difficulty in acknowledging Monsieur Regent of France. Such, however, is the weakness of this court, and its want of confidence in its allies, that it dares not venture on this conduct. The title of Regent had been given to Monsieur in the court almanac; but the edition was suddenly withdrawn, and the sheet in which the title stood reprinted.

A part of the army of Rouffillon is gone into cantonments; it is reduced to 18,000 men fit for service. Epidemical fevers still continue, and the number of sick and wounded is estimated at 16,000

The Spaniards being in possession of the town of Collioure, and the forts of St. Elme, and the Bellgarde, hope to maintain themselves in Rouffillon on, by strengthening their army with 20,000 recruits, raised as it is said, by government. But tho' they feel the necessity of quickening the slow motion of the Spaniards, if they would resist the impetuosity of the French, and though councils have often been held at Madrid, to which the best informed military men have been called there is every reason to fear, the French will soon assault Perpignan in mass, and that the Spaniards will be reduced to endeavor to stop their progress in the defiles of Catalonia.

It is affirmed, that the Vice Admiral Borgia who commands the division of Cadiz, will go to Carthagena, and command the Squadron which is to remain in the Mediterranean. (It is presumed that Langara will go to Cadiz, and perhaps act in concert with English on the ocean.

COWES, Eng. January 30.

The Hessian cavalry, 900 in number, are all landed, and the stores of Mr. Alderman Macaulay and other proprietors converted into stabling for their accommodation.

The horses begin visibly to recover their wonted strength and animation, and will, we have no doubt, in a short time make a respectable appearance.
