THE GREAT EXODUS ORDER.

HEADQUARTERS MILITARY DIVISION OF THE MISSISSIPPI, IN THE FIELD, ATLANTA, GA., September 12, 1864.—James M. Calhoun, Mayor, E. K. Rowson, and S. C. Wells, representing City Council of Atlanta.—Gentlemen:—I have your letter of the 11th in the nature of a petition to the military authorities to be removed from Atlanta. I have read it carefully, and give full credit to your statements of the distress that will be occasioned by it, and yet shall not revoke my order, simply because my orders are not designed to meet the necessities of the case, but to prepare for the future struggles in which millions, yea hundreds of millions of good people outside of Atlanta, have a deep interest.
