THE INDIANS.

A Party of Surveyors Surrounded by 175 Savages—The Fight Lasts All Day—Escape at Night.

The Plattsburgh (Nebraska) Herald says:— Through the kindness of A. L. Brown, Chief Clerk of the Surveyor-General's office for Iowa and Nebraska, we are permitted to publish the following letter, giving the details of the recent fight between a party of Government surveyors and a body of one hundred and seventy-five Indians.

Judge Strong's Argument.

Judge Strong then arose on the part of the contestants, and spoke in substance as follows:— I do not propose, may it please your Honors, to enter into a review of the evidence which has been submitted to the Court; that has been thoroughly and most lucidly discussed by my colleague, Mr. Mann, and on the other side my friends have discussed the evidence which has been presented.
