The bath is supplied by the Spring water and much appreciated by invalids. Deer, fox and wild cat are numerous, affording fine sport to the hunter, and the Lake, seven miles in length, with a depth of twenty feet, situated three miles and a half from the Spring, abounds in trout and other fine fish. A pack of hounds for hunting and boats for fishing will be furnished to the visitors. The best wines and liquors which the New-Orleans market can afford will be kept constantly on hand. Coaches can always be procured at Opelousas and Washington to transport any number of passengers to the Springs. Good music will be furnished and balls given twice per week, gratis.
