

TRAIN-ROBBERS KILLED. PLUCKY FIGHT OF MESSENGER SMITH ON THE SOUTHERN PACIFIC.

Annihilated by Two Armed Bandits, He Shows These Men a First Class Bullet in the Head and the Second Receives a Fatal Wound—The Heroism of the Messenger is Rewarded by Handsome Gifts. EL PASO, TEX., Oct. 19.—Mr. O. E. Smith, the messenger of Wells, Fargo & Co.'s express, who killed two train-robbers on Sunday night, gives the following account of the occurrence: "About 9 o'clock Sunday evening I left El Paso on the Galveston, Houston and San Antonio Railroad on the through east-bound passenger train as express messenger for Wells, Fargo & Co. About halfway between El Paso and Tuleta the train stopped. I heard a shot and thought it was a track signal torpedo. I then heard loud swearing, and on sticking my head out of the door I saw a man firing a revolver. I blew out the lights, and with Mr. Beardsley, clerk at the Fort Worth office, who was with me, we fired to the back part of the car. As I did this the robbers put giant powder in place and blew the door open. "I told Beardsley we had better get out. So he got out first with his 'gun' on his person. As I stepped down I left my 'gun' in the middle of the door on the floor. My intention was to hit the robber as I landed with my hands and feet on the ground, and then grab my six-shooter, but Beardsley was rather between us and I could not reach him. "The robber then wanted to get in and strike a light, and I volunteered my services, and got right back into the car. As I put my foot on the car floor I caught hold of my 'gun,' and turning quickly, placed it at the robber's heart and said, 'Die, die, you!' The ball went through his heart. "The other robber then fired at me, and the ball missed my head about the sixteenth of an inch, first back, and came near hitting the engineer. The other robber then deliberately carried his dead pal to the engine and ordered the fireman to put him on it, at the same time asking the latter what was the matter. Then the fireman answered, 'He is hurt pretty bad.' And he was hurt so bad that he will never hold up another train in this world. "Just at this juncture I, who had been peeping at the second robber to get a shot, but was prevented on account of the fireman being so near, noticed the fireman step aside a few feet, and my opportunity had arrived. I quickly seized it, and raised a single shot-revolver and fired. The second victim reeled and uttered a death-like sound, but recovered himself, and in a stooped shape, ran away. He was not far from the engine, and when his corpse, cold and stiff, and his face and body ridged with luskabot and covered with blood, was discovered in a little way to the left of the engine. "I killed the leader the first shot," exclaimed Smith, "and that's what did it. The object of the second man in getting his pal on the engine was to unhook the iron horse and get away from the authorities without leaving a clue." "Marshal White and United States Deputy Marshals Van Ripper and Ross and a posse are scouring the woods for the third man. Although Smith did not see but two men, three Indians are on the track of the third man, and claim that he was present. "The robbers' names, from their persons, are J. S. Emerson and Bernard M. Dechard. The first named was the first killed. The railroad boys at the Southern Pacific Depot think they recognize the dead robbers as a pair that was playing ball in front of the depot a day or two ago. Both of them look nearly alike. On Dechard was found a memorandum book with a buckshot hole through it. A plain gold ring, an imitation diamond ring and \$14.10 in money was found on his person. He was about five and a half feet tall and about twenty-five or twenty-six years old. He was a thin, pale man. "The other robber, J. L. Emerson, was about the same age as his pal. He was nearly six feet tall, weighed probably 170 pounds and had wavy hair and a smooth face, except a stubby beard. He was a muscular fellow. On his person was found \$145 in money and a check for a trunk issued at Terro Haute, Ind., Sept. 28. "Smith will receive \$4,000 for his little job. The Southern Pacific has a \$2,000 standing offer for each man. "A beautiful gold medal, one that will be a fitting tribute to the brave deed, to Messenger Smith will be given by the citizens of El Paso. "A freight was immediately behind the passenger train. Henry Campbell, passenger brakeman, put out his light and once ran back to flag the freight. A stray shot whizzed past his head, but he ran on about three miles and stopped the freight, thereby avoiding a terrible accident. "The old saying that a woman is at the bottom of everything is true again. Messenger Smith had a fine basket of grapes for his girl on the train, and he had a letter to a reporter that was this 'little token of love' that caused him to defend and fight at the risk of his life. Smith was the coolest person among the whole number of citizens he met to-day. He talked about the episode of last night as if it was in his line of business, and says he was not in the least excited or unmannered by the whole thing, completed, when he felt a little sick at his stomach. "A subscription list is in circulation to raise funds for the brave express agent. A number of persons have already signed it. Other lists will be started along the line of the road from here to the Rio Grande. "The theory of the robbery is that the pals of the two men on the train were waiting with horses at the beyond where the train was held up. The shot fired by the two robbers were the signals that after getting their plunder the two robbers intended to run forward with the engine and leave the rest of the train.

Political Democratization Will Follow the Government's Present Policy. LONDON, Oct. 19.—Mr. Gladstone's speech at the congress of the Liberal Federation, which opened at Nottingham yesterday, was welcomed with the greatest enthusiasm. Mr. Gladstone said he would tell them plainly that he was not there to say smooth things. It was a deplorable fact that the settling of the great Irish question, which might have been settled last year had there been a disposition to discuss it in a spirit of candor and fairness, had been again set aside and was still pending, its difficulties aggravated and its prospects uncertain. He had always told the Conservatives that the choice lay between coercion and Home Rule. The Conservatives had told them that home rule was an idle dream, but events had shown that it was not. A coercion bill had been passed against combinations, against the liberty of the press and the right of public meeting, and against crime. The Irish spectacle was now a grave and serious one, and if it continued it would drive Ireland into such a state that the difficulties of the Government would become almost insurmountable. He denied that he proposed Home Rule simply to advance Liberal interests. It was doubtful, he said, whether the Tories accepted Home Rule in its broad principles, and he said that he had accepted his proposals in 1872 and in 1883. He wanted a statutory Parliament in Dublin, subject to imperial control. There was nothing to prevent any reasonable man from coming with the Liberal party, and particulars without reference to this or that particular or detail. The immediate necessity of the day was to watch the way in which Ireland was being governed. If the Government persisted in their rash and foolish policy it would naturally lead to political democratization and render it in the end a matter of course. He had no objection to a Parliament truly representing their best and most enlightened conclusions, to deal rapidly and beneficially with Ireland. Only one word could describe the present system of Irish government. It was "impertinence." The events of the last few weeks in Ireland were not being tolerated in England. He regretted the action of the authorities at Mitchelstown. He admitted having used the words, "Remember Mitchelstown!" That affair must not be forgotten. The country had an account to settle with the Government in connection with that affair. The Mitchelstown authorities were undoubtedly wrong, yet Mr. Balfour, in behalf of the Government, had equivocally assumed the responsibility for their acts. The worst feature of the Mitchelstown incident was that the action of the authorities was not in a model and pattern for the whole of Ireland. The whole system of Government in Ireland required to be thoroughly reformed. The Government must be reformed, and the Government in all essentials. A radical change was wanted, and such a change an enfranchised nation alone could accomplish. Mr. Gladstone drew a glowing picture in defense of his administration of the law in Ireland and elsewhere in the Empire. He expressed himself as perfectly confident that if a general election were held to-morrow, he would result in the return of a Parliament resolved to do justice to Ireland.

THREE THOUSAND MEN STRIKE. PHILADELPHIA'S SHOEMAKERS DROP TOOLS TO HEAD OFF A LOCKOUT. The Men Claim Bad Faith on the Part of Manufacturers and Accuse Them of Throwing Many Men Out of Work to Punish a Few—Will Try to Run Shops With Non-Union Men. PHILADELPHIA, Oct. 19.—More than three thousand shoemakers in this city are idle on the streets this morning. They are ordered out by the Executive Board of District Assembly No. 70 in an effort to settle what has been called for two weeks the "shoemakers' middle." The strike was ordered, as the district considered that the attempt of the manufacturers to lock out the shoemakers, for no cause, was outrageous, and they held that a strike must be ordered so as to resist their encroachments, as the district had done all it could do and all it ought to do to settle the benchmen's trouble. This action was a great surprise to the manufacturers, who thought the men would not get out, but would allow themselves to be locked out. The district held a meeting at 505 Chestnut street last night, which was largely attended. The meeting was a scene of great enthusiasm and the manufacturers were denounced. Evidence of crooked behavior were related and the sentiment was strongly expressed that the manufacturers had violated all the rules and had no ground for throwing their employees out of work to punish a few men. The Press Committee after adjournment gave out the following statement in reply to the note made by the Manufacturers' Association: "This is an impartial statement of the case of District Assembly No. 70. In the communication sent from this district assembly to you, we advised a strike in any of the shops belonging to the Manufacturers' Association and declared that we would not support any member of our order without hindrance, official or otherwise. We positively refused to give our moral or financial aid to those who were in doing themselves or their employers wrong. The manufacturers in a case exactly similar to the present case when the beet paraders struck and were ordered back by the Government, they placed declared vacant. The manufacturers accepted that decision and hired new men, but afterwards they refused to give our order any support. The manufacturers asked the district to do the impossible in demanding that the benchmen who had been ordered back by the Government should not expect their aid, and in asking us to try them in a week, when they knew that it might take a year to try the men, even if they had violated any laws. The manufacturers in the present case advertised for men in this and other cities, and they have been successful in getting men from other cities. The rates of the joint board have never been higher than those of the manufacturers. They have blacklisted some of our best members, and in some cases went into shops and asked the proprietors to give up their business. They have driven some of our people out of the city. When uniform bills of wages have been presented, they have combined to reduce our wages to the lowest rate in the adjacent States. These and other facts the district resolved to hold the action of their Executive Board in declaring a large sum. "The district also passed the following resolution: Resolved, That in view of the fact that the Manufacturers' Association has given to the press statements derogatory to the present action of the Board, we, the local assemblies of the district, assembled together, do give our unqualified and hearty support to the present action of the Board, and we have proved most efficient and trustworthy selections. Furthermore, be it Resolved, That the District Assembly is not to be dictated to by the manufacturers in the choice of its Executive Board. "By this action over one thousand eight hundred dozen pairs of shoes are left unfinished in Zeigler, Brown, Gaylor and other shops, according to their output, in other factories. "The manufacturers say they do not know where the men will go for the future, and they do not know whether they will try to start with non-union hands or not. "James Cotter, Jr., who employs over one hundred men, says he has no objection to a communication yesterday that he will change his system of lasting and that his men have agreed to abide by the old prices until July. "The manufacturers outside of the association are making all preparations to start a big business and will doubtless absorb a great many of those who strike. HAHN STILL ON THE SICK LIST. Not Able to Do Police Duty, but Said to Be Well Enough to Enjoy Himself. Policeman Edward Hahn, the slayer of Jack Hussey, is still on the sick list and failed to report for duty at 6 o'clock last evening as he should have done. Although suffering from nervous prostration, according to the police surgeon's diagnosis, Hahn is able to float freely about his city, holding bar-room levees and talking freely about the case, and to quote his own eloquent language. Capt. Robinson, of the Tremont precinct, to which Hahn has been sent, says that he is a great curiosity among the residents. "Goad-town" to see Hahn, and that inquiries concerning the post he is to cover are frequent. He is so well that he can walk to the desolate region of the city where there is little travel at night, and where curiosity-mongers do not congregate. There is a great deal of talk about the case, and it is expected that he will be back to his duty in less than a week after his resumption of police duty.
