KERR'S TRIAL SET FOR MAY.

His Counsel Refuse to Enter Any Plea to the Indictment.

The second dilatory motion interposed by Thomas B. Kerr, in the Court of Oyer and Terminer, to prevent his trial on the indictment for bribing the Board of Aldermen of 1884, was decided adversely to him to-day.

Mr. Kerr had not been properly indicted could not be received. Messrs. Cockran and Rollins, counsel for the defense, thereupon renewed their motion to set aside the indictment on the ground that there was no indictment before the Grand Jury on which the indictment was based.

Assistant District Attorney Semple objected to the reception of this plea, and the Court promptly refused to receive it and ordered the defendant to plead.

The defendant refused to plead other than "Not Guilty," and the Court ordered the case to be set for trial on May 2d.

5 O'CLOCK EXTRA WHO HAS THE UPPER HAND?

EACH SIDE CLAIMS TO HAVE THE B.T.T.R. OF THE BREWERS' TROUBLES.

Although the Breweries Are at Work, Yet the Men Are Vigorously Boycotting Pool Beer—The National Keopers Expected to Uphold the Union in the Great Fight—The Men Get Encouraging Reports.

The brewers' lockout and the men's boycott show little signs of weakening. Each side in the fight claims to have the upper hand.

The work of boycotting pool beer is still carried on vigorously by the unions, as indicated in the action taken by the independent local unions and the sections of the Central Labor Union. The lockout men to-day asserted that the boycott daily grows more effective and that it is already proving disastrous to all the pool brewers.

The lockout men gathered at Clarendon Hall this morning in full force and listened to reports from committees' pickets.

The report was made that about twenty small brewers were about to yield and abandon the pool. This caused great rejoicing. Many national keepers were said to have changed from pool to non-pool brewers, and that others are anxious to do so, but have not been able to secure supplies.

The action of the national keepers and the refusal of the pool to non-pool brewers with the men was commented on adversely to the employers, and the belief expressed that the national keepers will take such action to-night at their meeting, at 29 East Ninth street, as will tend greatly to bring the pool to a full sense of the situation.

Regarding the arrangement made by the brewers, it was said that the men were dissatisfied with the management of the lockout, and declared that the attitude of the Knights of Labor was detrimental to success in the struggle for the men's recovery.

Some asserted that unless something were quickly done to obtain the active support of the Knights it would be useless to continue the fight, and that they would return to work on their own account.

The leaders asserted that it was best to await the result of the investigation by the Arbitration Board before acting independently.

The Stair Builders' Strike Ended. The strike of the twenty-five stair builders in the employ of a variety of contractors, Sixth street and Jackson avenue, Long Island City, came to an end to-day by the return of all the men to work.

The West Side Ass'n reports that it is pushing the boycott on pool beer.

The International Boatmen's Union has voted against organized labor having independent political action.

The Hearts of Oak Association has resolved to discipline any of its members who refuse to obey the order to quit the pool brewers.

The Welcome Association of Couples has settled the differences existing between its members and the
