They are all pinning their faith on the cheese county statesman, and hope through him to divide the Federal pap of the Harrison Administration among themselves.

Ex-Coroner Edman, who was defeated for re-election last fall, is quoted as having said in relation to his failure:

"I blame for my failure, months ago, Len Giegerich will go out of office April 1, and I'll get his place."

Leonard A. Giegerich is United States Internal Revenue Collector and it is known that Edman is making a hard push to succeed him.

This knowledge came to John J. O'Brien, and he once set to work to defeat Jake Patterson's lieutenant.

Morris Friedman, the old-time friend of ex-President Arthur, and the predecessor of Giegerich, was seen, and urged to make the fight against Edman for the position, in the interest of Platt and O'Brien.

Mr. Friedman consented, and will stand as the representative of the German Republican element.

He recently paid his respects to President-elect Harrison at Indianapolis, and, although he is now in New York, he is known to have been in the city at the time of the interview, as his serenely happy manner indicates that it was not at all unamiable.

That the intention to inform independent Republican organizations in Amity street, assembly districts did not cease with the recent enrollment, is evidenced by the revolt of the Creighton faction in the Sixth, where an independent organization opposed to Simpson's leadership has been formed.

The pertinacity of Peter C. Bamberger in his fight against Nugent in the Fourteenth district also shows that the O'Brienites have not given over their intention to continue the war.

Bamberger says that Edman approached him recently and asked him to let up on Nugent, and in return he will be rewarded by a rich Federal position.

Peter says that he rejected the proposition with scorn, especially as he don't think that the faction to which Edman belongs will have any Federal patronage to bestow.
