POPOFF'S OWN LIFE AT STAKE

Did Mary Petrikovsky Die by Murder or Accident.

Evidence for the Prosecution Closed and the Defense Begun.

The trial of John Popoff, the young Russian who shot and killed pretty Mary Petrikovsky in January last, was continued in General Sessions this morning.

The shooting occurred at the home of the dead girl's sister, 103 Stanton street.

Popoff had made several proposals of marriage to the girl, which were rejected.

The day of the shooting Mary left her father's house about 2 o'clock to spend the afternoon with her sister. Here she met Henry Jacknovich, the brother of her sister's husband, and the two young people set down to a game of cards.

Soon afterwards Popoff, who lived in the game, came in and took from his pocket a nine-chambered 22-calibre Russian revolver, which he began to fidget with in a reckless way, pointing it at everybody in the room.

Jacknovich interfered with some degree of success, and finally returned his card-playing with the girl.

At this moment the revolver was discharged and Mary Petrikovsky fell dead, shot through the brain.

Popoff was promptly arrested and returned to the Tombs, where he has since remained awaiting trial.

The case came before the court-room at 12 o'clock accompanied by his counsel, Col. Howe and E. B. Massey.

STOCK REPORTS.

Bears Get a Chance at the Market at Last.

A Threatened Railroad War Acts as a Damp.

Great Excitement Over a Drop in Sugar Refineries.

The bears were on top to-day. Speculators in railway stocks were marvelling at the nerve of Allen Marvel, of the Atchison, in serving notice on Jay Gould that if in twenty-four hours, Gould's Missouri Pacific did not restore rates, the Atchison would cut passenger rates between Kansas City, Cheyenne and all Texas points to \$1.

This following on the heels of the San Francisco and Atlantic and Pacific, fairly took the breath out of operators and acted as a damper on speculation.

Marziani holders of Atchison were alarmed by President Marvel's defiance, and there was a scramble to get out, the stock falling to 4 1/2 against 5 1/2 after the close yesterday.

Judge Ingraham's decision giving judgment for the Sugar Trust in the North River Sugar Refining Company brought about an advance to 95 in sugar certificates. The decision advances the lie pendence and the injunction against the payment of dividends and leaves the Trust practically free to change its form of organization. The Court of Appeals is now to be heard from.

Everybody is now waiting to hear from Gould, and if the past is any criterion, the "Littleman" will not exhaust his patience.

Unless there is a truce, railway history will be made at a rapid rate within the next twelve months. Gould is renowned for his fighting qualities, and is fertile in resources. His first move is therefore anxiously looked for.

The Richmond Terminal management is about to offer to the stockholders 20 shares of new stock at \$20 per share for each 100 shares of their holdings, and in addition the right to subscribe for \$1,000 5 per cent. lateral bonds at 80. The success of the scheme is assured, a leading banking firm having guaranteed and underwritten the plan for 15 per cent. commission. An offer by an English syndicate of \$25 per share was rejected owing to the adoption of the President's plan to-day.

During the last hour Sugar Refineries broke from 95 to 90, and everything else dropped in sympathy. The dealers were large and intense excitement prevailed.

Another Outrage, with a Woman as Its Victim, in Siberia.

The French Murderer's Arrest Announced at Havana.

London, May 21.—A gentleman just returned from Siberia brings report of another horrible outrage, of which he was an eye-witness.

It took place in the prison at Kara, where the previous outrages occurred which have aroused Europe.

In this case, as in the others, the victim was a woman. The murderer of the Paris assassin Gonfse, was arrested here this morning.

Eyraud's victim was Gonfse, a process-server, who disappeared from Paris last July, and whose dead body was found in a ditch near Lyons. A broken trunk was found near by.

The affair was a mystery until a young woman, Gabrielle Dompard, came to the Paris police and confessed that she enticed Gonfse to her rooms, that Eyraud might strangle him.

The poor creature was wasted by consumption and unable to rise from her bed.

By the order of the Governor, she was dragged half-naked by soldiers into the courtyard of the prison, thrust into a sledge, and driven off at a gallop in the dead of winter.

The woman died before arriving at her destination.

A demand had been made for the removal of the Inspector, Bedrosian, for wantonly shooting political prisoners under convoy.

Settled that Stanley Will Be Married in the Abbey.
