

WALL ST. STOCK REPORTS.

Western Buyers' Large Orders Send Up Quotations of Shares.

No Gold Exported on To-Day's European Steamships.

Favorable Showing of the Weekly Bank Statement.

The West has evidently turned bullish on the stock market, and this morning Chicago operators were liberal buyers of the Grangers, Union Pacific and other specialties.

Local traders have evidently been "left" again, and some of them are heavily short. Only the other day the cry was that there must be a smash before the market could turn.

Certain rumors were circulating in the market that the amount of gold in excess of legal requirements up to \$10,484,823.

The rise in prices ranged from 1/4 to 1/2 per cent, and was most marked in Aitchison, Union Pacific, the Grangers and Missouri Pacific.

The market closed very steady on the favorable bank statement.

The European steamships which sailed to-day took no gold. The French liner, which had on board \$200,000 in silver bars and \$9,372 Mexican silver dollars.

The bank statement was favorable, showing an increase in reserves of \$2,757,206, which brings the amount held by the banks in excess of legal requirements up to \$10,484,823.

LITTLE PATSY'S SAD FATE.

The Pride of the Hook Drowned Off Jackson Street Dock.

His Only Thought During His Struggle for Life Was His Mother's Anguish.

Little Patsy, the pride of the Hook, the handsome harmonica player, who was the favorite of the girls, was drowned yesterday.

Patsy was drowned yesterday off the Jackson street dock in the sight of playmates, who watched his brave struggles and the heroic efforts of his would-be rescuers.

Patsy lived with his mother, younger sister and two brothers at 628 Water street. He was thirteen years old and was to the fifth grade of school No. 54, in Broome street.

Patsy was a good scholar, when he wanted to be, but he was an ardent swimmer, and he did not like to be cooped up in the school-room on warm days.

He would rather gather a crowd about him on the dock and play his harmonica.

It was too warm to go to school yesterday. Patsy thought, and when his mother insisted that he go to school, he started. But he did not go to school.

He went down on the Jackson street dock and soon was surrounded by a crowd of boys for whom he played merry tunes.

It was about 11:45 o'clock when during the skylarking Patsy's harmonica was knocked out of his mouth and went flying into the river.

Patsy stood on the stringpiece a moment and then boldly plunged overboard without removing a single piece of his clothing.

Scams are loaded at the Jackson street dock, and much dirt falls overboard, making a muddy bottom.

The boys knew that it was a dangerous swimming place, and when Patsy did not come at once to the surface they surmised that he had struck in the mud.

Patsy kicked himself loose, as the mud which came to the surface with him showed, but the tug William Murphy was steaming about the dock and the swell threw Patsy against a canalboat.

Again he sank, and when he rose again he was apparently aware of his peril, for he shouted out to the boys on the dock:

"Don't let me take me body home if I drown, Andy. I'll make mother feel bad. Take me to an undertaker's shop."

Then Patsy sank for the last time. He was a long under water, and soon a crowd had gathered to watch the efforts of the young rescuers.

Finally at 2:45 o'clock in the afternoon Andy O'Leary brought the body to the surface. It had stuck between two logs, and was released with difficulty.

Among those who had been brought to the scene by rumors of the boy's drowning was Patsy's little sister Agnes. When she saw the body of her brother lifted out of the water who tried to get up and get some tea.

AGENT BRITTON A PLUNGER.

Bookmaker Irving Sues Him for Alleged Betting Debts.

Britton Says He Lost \$100,000 on the Races, but Is No "Welcher."

Robert G. Irving, the well-known bookmaker at race tracks, accuses Joseph A. Britton of being a "welcher" and has sued him for debts incurred as a loser on the races.

Britton is the Chief Agent of the Society for the Enforcement of the Criminal Law. Mr. Irving says that while Britton was at the Morris Park track last Summer and again in suppressing the evil of pool-betting he bet on the races at his Irving's box, and lost heavily, doing all his betting on credit, and that he now recollects the indebtedness thus incurred.

The suit is for recovery on a note for \$500, dated Feb. 25, and due three months after date. Attorney Leroy B. Crane brought the suit. The note was one of three given by Britton to Irving, in exchange for several checks for small amounts, aggregating \$1,000.

Mr. Irving alleges that Britton approached him at the Morris Park track, and asked him to bet for him, but had no money with him. Irving would take his commission on he might pay him at the close of the races if he was a winner, and if he was a loser he would give Irving his check for the amount of his losses.

This is a common practice with the Lottorials, and was the case with Britton. Irving was reported to be wealthy, and had been a lamson-plunger for years; so Irving accepted the proposition, and as a result, at the close of the season, the bookmaker had several small checks that he had not presented for payment.

Then, says Irving, Britton gave his notes, as stated. The one for \$500 was not paid, and Irving was forced to sue for it. Irving says that he has lost \$100,000 on the races, but is not a "welcher."

The money failed to materialize and suit was begun May 25. Lawyer Crane says it is not a debt of honor. The lives pool bill legalizes betting at the race tracks, and the indebtedness is therefore legal. Besides, Britton gave the notes, not for betting debts, but in exchange for his checks, and therefore for a valid consideration.

Irving says he would pocket the loss if Britton had no money, but he believes he has \$50,000 worth of real estate, picked up during his connection with Anthony Comstock, and considerable real estate besides.
