The Stock Exchange has decided that after the date the New York Quotation Company must pay \$100 a day for collecting quotations on the Board, and the Company has retaliated by sending out a notice to all its subscribers that after April 1 they must pay \$20 a month instead of \$10 for the use of tickers.
