LAST EDITION. WM. ASTOR BURIED.

Trinity Chapel Crowded During the Funeral Services. The Body Laid at Rest in Trinity Cemetery.

Many Famous Men Present in Honor of the Dead Millionaire.

Trinity Chapel in West Twenty-fifth street, third size of New York's sanctuaries, was crowded to the doors this morning at the funeral of William Astor, and a thousand men and women thronged the street.

It was a remarkable gathering for such an occasion. There were hundreds of women whose cars dropped the working or holiday class of life-savers of tenants of William Astor, who said kind words about their dead landlord.

At 10 o'clock the doors were thrown open, the arrivals by carriage and on foot were soft men of business, plain and substantial, with their wives in rich and tasteful dress.

At 10:30 the service was finished and the congregation was dismissed. Then sexton Albert Meyer and his assistants carried the casket from the mortuary chapel through the body of the church and placed it to the left of the main entrance in the front vestibule.

A few minutes later James Roosevelt Roosevelt came about to the Twenty-sixth street gate of the chapel yard, and there he received in turn Mrs. Roosevelt and their children.

Among those present were Mr. and Mrs. William H. Belmont, the venerable David H. Burton, who was the father of the Astor family in America, the grandfather of William Astor.

LAST EDITION. SIX MONTHS IN JAIL. "Hon." Patrick Greville-Nugent's Sentence at London.

He Pleads Guilty of Assaulting Miss Price in a Railway Car.

Drunkennes His Excuse—The Full Charge Is Not Pressed.

London, May 12.—(By Associated Press.) A sensation was caused this morning when it became known that Hon. Patrick Greville-Nugent, a brother of Lord Greville, who was indicted for having assaulted Miss Marion S. Price in a compartment of a railway carriage, had pleaded guilty in the North London Sessions of common assault.

The accused had repeatedly stated that the case was one of attempted blackmail, and his plea when he was arraigned was a great surprise to his friends.

The prisoner was sentenced to six months imprisonment at hard labor.

The assault was committed on a train on the London, Brighton and South Coast Railway on the night of April 18.

The prisoner pleaded in extenuation of his offense that he was drunk at the time.

The Court agreed to accept his plea of guilty of common assault after counsel for the prosecution had agreed that the grave charge should not be pressed.
