

WHO ELOPED WITH DERANZ?

A Beautiful Brooklyn Girl Gone with an Alleged Forger.

Checks with Which He Paid Passage-Money are Repudiated.

The agents of the North German Lloyd steamship company in this city this morning began an investigation into the acts and whereabouts of Edward Deranz, who is supposed to have sailed for Germany Oct. 4 on the steamship Lahn, accompanied by the daughter of a well-known citizen of Brooklyn.

It was alleged that Deranz appeared at the steamship office Sept. 28, and selected a stateroom on the Lahn for himself and wife, tendering in payment a check for \$350, drawn on a bank in Dover, N. J., and signed "F. L. Slater."

The check was accepted and the balance over the passage money, amounting to nearly \$100, was returned to him.

Mr. Slater is proprietor of the Hotel Arlington, at Lake Hopatcong, and President of the Mount Arlington Land Company.

Clerks at the steamship office say that Deranz called again the day before the Lahn sailed and induced them to cash another check for \$100, also signed "F. L. Slater."

The agents of the steamship line have notified the home office at Bremen to look out for Deranz. It was at first suspected that he and the young woman who accompanied him did not sail on the Lahn, but waited for the Stearn.

Advices have been received from Bremen that the Lahn sailed on the 10th inst. It is the custom of the purser to notify the New York agents of any vacancies in the sailing list on the arrival on the other side. The steamship people are confident that Deranz is in Europe.

The agents, it is declared, will look to Slater for payment of the check. It was learned at the office of the steamship company that the practice of taking checks in payment of fares is a common one, but that this is the first time they have been victimized.

The company has eight agents in New York, which to act in case there is any trouble. Deranz was formerly clerk in Slater's hotel. He is said to have a wife and child in New Jersey.

The North German Lloyd people say that if they can get their hands on Deranz, he will be prosecuted to the full extent of the law. All particulars regarding the young woman who is supposed to have sailed with Deranz are jealously guarded by those having knowledge.

She is said to be a very beautiful girl, who became intimate with Slater while a guest at the hotel where he was clerk.

25,000 CHILDREN IN LINE.

Catholic Parochial Schools Begin the Columbian Celebration.

American Flags Carried by the Host of Lads and Lassies.

The Columbian celebration in Brooklyn was begun to-day with a parade of the pupils in the Catholic parochial schools.

There were about 25,000 children in the procession. Almost every child carried an American flag, and the effect was very pleasing.

The parade was marshaled by Col. John G. Kelly, of the Forty-seventh Regiment, and was in four divisions. It formed at Bedford and Wiloughby avenues and marched through Lafayette avenue to Adelphi street, where it was dismissed.

Bishop McDonnell, Mayor Hoody, the Board of Aldermen and many of the clergy reviewed the parade from a stand erected in front of the new cathedral on Lafayette, between Vanderbilt and Clermont avenues.

The parade started shortly after 1 o'clock this afternoon. The line of march was usually packed with spectators and the whole Eastern District appeared to have turned out to cheer the marching host.

There were sixty parishes represented in the procession. The companies in each church organization formed fourteen, from single rank, with a captain and two lieutenants.

An interesting feature of the parade were the schoolgirls, who marched as promptly and as well as the boys.

The Staten Island schools, accompanied by their own band, made a distinct impression and were cheered to the echo.

The Columbus club will have a celebration at the Academy of Music to-night. There will be a concert of 400 voices, under the direction of Prof. Bernard O'Donnell. An orchestra of fifty pieces will furnish the accompaniment.

EDDIE DIVENS ACQUITTED. Irresponsible, the Jury Says, When He Killed Max Clerget.

Eddie Divens is free to-day. The jury which tried him for killing Max Clerget in the General Sessions court-room after Clerget had pleaded guilty to the charge of criminally assaulting crippled and weak-minded little Max Divens, declared that he was innocent of the crime, on the ground that his mind was unbalanced.

It took the jury an hour and twenty minutes to agree, though the verdict was fore-shadowed by the applause of the court-room audience when Lawyer Abraham Levy, in his plea to the jury, declared that he believed that Eddie Divens had only done what he would do himself if the man who had ruined his work as a clerk.

Recorder Smyth, in his charge to the jury, advised them to get the best of his judgment and duty as a citizen and an officer of the court, and then choose between the charge of Clerget as one of the vilest known to the law.

All this time Eddie Divens had in his own mind been making the most eloquent of his own case as he sat mute, quite incapable of comprehending the proceedings, swaying back and forth in his seat, his eyes staring, a meaningless grin on his idiotic face, or as meaningless tears dropped from his eyes.

Eddie was discharged into the custody of his uncle, the kind-hearted John Armstrong. He will be cared for by another uncle, named Barclay, but it is not likely that the poor boy will live long to trouble anybody. The ruin of his sister seems to have completed the wrecking of an always feeble mind, and he is dying at the top.

AS TOLD BY SENOR GOMEZ. His Wife Pawned Kaufman's Diamonds to Secure Her Debt.

The examination of Mr. and Mrs. Jose Gomez, who have been charged by Mordecai Kaufman, a jeweler of 120 East Ninety first street, with stealing \$10,000 worth of diamonds, will come up in the Tombs Court this afternoon.

Jose Gomez, who had at first referred all questions to his lawyers, was more communicative when interrogated by an EVENING WORLD reporter, and gave the following version of the transactions with Kaufman that led to the arrest of Gomez and his wife:

"My wife had been a sufferer from some head trouble for a long time. Her doctor advised her to get away from her home and to occupy of some kind she might find relief. Accordingly she engaged in this diamond-selling business for Kaufman."

"My wife had some money of her own, \$2500 of which she loaned to Kaufman in notes and received as collateral security a lot of jewelry. Of this transaction I knew nothing until she had been arrested, when I received a letter from Kaufman, informing me that my wife had jewelry belonging to him which she had pawned to him. My wife then told me how she had obtained the jewelry, and showed me the notes that Kaufman had given her. I was very indignant, and sent word that she should at once cancel her debt to my wife and the jewelry would be returned to him. My wife had pawned almost all of this jewelry for \$2500, so that she was still \$100 short of the amount which she had advanced to Kaufman. Instead of replying to my letter, Kaufman had my wife and myself arrested the next day."

Mr. Gomez also said that he felt resigned to his present situation, as he is sure that his wife is indicated in the end. Gomez was an Inspector of Police in Rio de Janeiro some years ago.


