GORDON SAYS HE'S A MARTYR.

He Accuses His Relatives of Putting Him in an Asylum.

Twice He Has Escaped from an Inebriate's Home.

John Gordon, a saloon-keeper at 508 North fifth street, Williamsburg, who has twice escaped from the Inebriates' Home at Fort Hamilton, and only last Monday escaped from the asylum at Flatbush, was a prisoner in the Lee Avenue Police Court this morning.

To an Evening World reporter Gordon told this story: "I own the saloon at 508 and the house at 508 Driggs street. I admit I drink a little, but on no occasions, in order to get me out of the way, my immediate relatives have had me sent away."

"Two weeks ago they sent me to the Inebriate Asylum at Flatbush, and Monday morning at 11 o'clock Dr. Durea and there was sent me anything the matter with me and sent me away."

"I went back to the store and yesterday two officers dragged me away from there. They assaulted me and one of them struck me on the head."

"This story is denied by the relatives, but it is a matter of record that he left the Inebriate Home twice and was discharged from the asylum by Dr. Durea.

TAXPAYERS FIND MUCH FAULT.

High Rate Creates a Desire for Annexation to New York.

The crowd of people who wanted to get their tax bills began to gather in the hallway of the Municipal Building in Brooklyn at 7 o'clock this morning, and when the office opened the corridor was almost impassable.

Taxes for 1892 were due today, and when the bills of the property owners received their bills they expressed their feelings in strong language, and said they were anxious to have Brooklyn annexed to New York, where the taxes are now about one-half the rate in Brooklyn.

The tax rate on \$100 was \$25.70 in 1890; \$25.00 in 1891; \$27.70 in 1892. Property assessed in 1892 at \$40,000, will pay the amount of \$10,908.00, an increase of \$1,428.42 over last year.

"A house worth \$10,000 in Brooklyn is taxed \$1,914.11 and one man, while a \$10,000 house in New York is taxed only \$32.50."

The officials excuse the increase on the grounds that within the past year the police force has been increased, and that many streets have been widened.

The receipts at the tax office to-day amounted to \$2,835,357.48, an increase of \$600,000 over the first day's receipts last year.

FIRST CATCH OF BURGLARS.

Several Arrests for Recent Crimes in Brooklyn.

In spite of Supt. Campbell's order to the captains of the various Brooklyn precincts to look out for burglars and sneak thieves, a large number of robberies were reported at Police Headquarters this morning.
