A Verdict Reached by the Jury in Fifty Minutes. The Prisoner Released and Given an Ovation on Park Row.

There was a large gathering in Part II. of the Court of General Sessions to-day to witness the last scenes in the trial of Joe Wogan, indicted for murder in the second degree in killing John J. Wogan in Tom Gould's sixth avenue dive, Christmas morning a year ago.

Tom Gould, "Assistant Manager" Joseph O'Connor, Ida Adams and the other witnesses who were in Tom Gould's early Christmas party when Wogan lost his life, attended themselves to-day from court, having performed their parts as witnesses in the trial.

Their places and many others were occupied by short-haired, square-jawed men and many women. The attorney was all in and Prosecutor Mulvey and Lawyer Charles Stecker had presented their respective arguments to the jury when court adjourned last evening, as told in THIS EVENING WORLD'S Sporting Extra.

All that was left was for Judge Fitzgerald to explain the law of homicide in his various forms to the jury prior to the retirement for deliberation. Selling, who has passed the last three nights in the Tombs, was perfectly calm, though his liberty for the remainder of his life as in the hands of the jury.

When the court convened Jurymen Robert F. Fowler, the captain of the second chair, appeared with a pale face and swollen eyes. He is presently in the Tombs, and was obliged to leave the chamber to get a breath of air. He explained that he had been the victim of a peculiar accident.

Last evening he was supervising the work of Christmas decorations in St. Ann's Episcopal Church, of which he is a vestryman. Workman was hanging a star of Bethlehem in the dome. Mr. Fowler was looking up at the star when it fell and struck him on the hammer. It fell thirty feet, landing just over Mr. Fowler's right ear.

It was necessary to close the court and the victim was still weak and faint. He was able to go on with his work as juror, however, and the trial began at 10 o'clock. The jury retired at 11:35 p. m. and returned at 12:15 p. m. after only three hours of deliberation.

There were many friends of selling in court and at least one factor dropped his hammer. His face was wreathed in smiles, and he hurried out of court. A hundred men and a half dozen women gave him an ovation in City Hall Park and escorted him down Park Row.

A talk with the juror reveals that none of them knew that a coroner's jury had exonerated selling for shooting Wogan.

More than \$4,000,000 was appropriated for the public schools by the Board of Estimate and Apportionment to-day. That amount does not include money to purchase sites for new school houses and a headquarters building, for which the necessary funds will be raised by the issue of bonds.

Commissioner Lammie, Holt, Gerard, Macley, Wehrum, Sanger and Straus were present to represent the Board of Education. President Hunt was reported to be sick.

The amount asked for was \$4,893,200, an increase of \$445,000 over the current year's appropriation.

The item for salaries of teachers in primary and grammar schools was \$3,212,650, or \$84,050 more than for 1891.

Commissioner Lammie quoted the words of Stephen A. Waiker in 1881, that a commissioner, who in making a demand for more money for salaries and other uses, said that the increase was made necessary by the increased attendance at the schools. It was impossible to reduce the pro rata cost of each pupil.

There are twelve new schools to be provided for in 1893.

The allowance for teachers' salaries was \$2,000,000, the same as last year. The appropriation for this year was \$2,000,000, and the Board of Estimate having refused to reduce that amount from school funds, the schools would have to close down next Tuesday night.

MURDERER ROHLE SENTENCED. To Die in the Chair the Week of Feb. 6.

An Appeal to Be Taken and It Will Act as a Stay.

Frank W. Rohle, who murdered Frank G. Plank at 130 West street Sept. 20 last, was this morning sentenced to death by Judge Martine in Part I. of General Sessions.

Rohle will die in the electric chair during the week of Feb. 6, 1893.

Lawyer Goldberg, who defended Rohle at his trial, moved for a new trial on the ground that the jury had been misled on a point of law, and consequently a writ of habeas corpus was granted.

He also claimed that the Assistant District Attorney, in alluding to Plank as a veteran soldier, and consequently a man incapable of committing a crime, had misled the jury.

Rohle did not move a muscle while in the court, in his measured tones, imposed sentence. An appeal will be taken.

DIRECTOR FISKE DROPS DEAD. He Was About to Enter a Meeting of the Board.

Connected with the American Exchange Bank Forty Years.

Joseph M. Fiske, one of the oldest directors of the American Exchange National Bank, dropped dead this morning about 10:30 o'clock, as he was entering the bank to attend a meeting of the board.

He came in with his nephew, William Blodgett, and had just reached President George C. Coe's office in the rear of the room when he suddenly fell to the floor.

Several directors ran to his assistance and carried him to a lounge, but he was unconscious.

A physician from the Equitable Building was hastily summoned, but on his arrival he pronounced Mr. Fiske dead.

Whether death was due to apoplexy or heart disease could not be ascertained this morning.

LAST EDITION. GRIPPLING FIREMEN.

The Department Placed at a Serious Disadvantage. Linemen Discharged and the Alarm System in Danger.

The Result of an Attempt to Cut Down Expenses.

The Fire Department in its present condition is seriously crippled, and should a serious emergency arise it would be impossible for the people of this city to have a right to expect from it.

Owing to a lack of funds, the appropriations for the current year having suddenly given out, the Commissioners have passed resolutions, which are now in force, ordering retrenchment and the cutting down of expenses in all directions.

In the first place the extra telegraph force has been suspended, and the stoppage of work in the repair shop and the furnishing of any further supplies or materials for the shops or any of the company headquarters has been ordered.

This means the throwing out of employment of forty men, whose duty it was to look after the fire-alarm wires and see that they were always in perfect working order in every part of the city.

For want of proper supervision the wires might fall in an emergency and the result might be the loss of thousands of dollars' worth of property.

Another serious matter is the fact that the present reduced force of such an accident is likely to rise at any moment.

On the other hand, the Commissioners in expenditures already specified, the Commissioners say they have been obliged to cut down the supply of bedding and feed for the horses.

It was reported that the Commissioners found some time ago that the appropriations for 1892 was not going to look good, and that the present balance of the fund was about to be exhausted.
