Simple and unostentatious, as had been her life, were the funeral obsequies of the late Mrs. William C. Whitney at St. Bartholomew's Church.

Fully an hour before the services, which were set for 10 o'clock, the spacious auditorium began to fill up.

All the morning there was a constant stream of callers at the Whitney residence, 2 West 17th street.

Upon the plate rested a cluster of palms, sprinkled with lilies of the valley, and upon it a large bunch of violets tied with violet ribbon.

The first of the party to enter the church were the pall-bearers, who were: George Cleveland, Cornelius Vanderbilt, George Peabody, etc.

NOW SUMMING UP. FIVE SAILORS LOST. Gardner's Long Trial for Extortion Almost Eaded.

Dr. Parkhurst III and Sends a Deposition to Court. Little Clifton in Rebuttal Declares the Agent's Story a Lie.

The last day of the trial of Supp. Charles W. Gardner, of Rev. Dr. Parkhurst's Society for the Prevention of Crime, indicted for attempted extortion, began this morning with the reading of a deposition signed by Dr. Parkhurst himself, who was too ill to come to court.

William Travers Jerome read the deposition, after objecting and excepting to Recorder Smith's statement, in reply to Prosecutor Wellman, that the counsel for Gardner might read the deposition, subject to all the limitations of the rules of evidence.

The deposition stated in substance that Oct. 14, 1892, Supp. and Chief Detective Lawler reported to Dr. Parkhurst and Gardner Frank Moss, of the Board of Managers of the Society for the Prevention of Crime, that one George Chauncey Grant, formerly an agent of the Society, was levying blackmail in the name of the Society upon the keepers of disorderly houses and other law breakers.

She denied that Gardner had ever suggested to her that she make an affidavit and declare that she was the author of her story that Capt. Devery knocked that bundle of \$100 in marked bills out of her hand at the time of Gardner's arrest was a lie.

She also denied Gardner's story in evidence that she had been on the boat with Stephen McDonough, a saloon-keeper at 131 Third avenue, corner of Seventy-second street, on the night of the trial on the question of Gardner's reputation, but the man was finally released on his own recognizance.

Bark Alice Totally Wrecked Off Long Beach, N. J. Part of Her Crew Thrown Out of a Boat in the Surf.

Life-Savers Rescued the Rest with the Breaches Buoy. Report of a shipwreck, with the loss of several lives, during the fog and storm of yesterday evening, was made this morning by Supt. Havens, of the Fourth District Life-Saving Service, at Point Pleasant, N. J.

The Norwegian bark Alice went ashore off Long Beach, N. J., at 9:30 o'clock last night. The sea was running high, and the bark, which was in ballast, pounded heavily.

As quickly as possible, the life-savers, seeing that it was impossible to accomplish anything with their boat, succeeded with their effort in getting a life line over the bark, and by means of the breaches buoy all the remainder of the crew, including the captain, were rescued.

The Alice was bound from Dunkirk to New York in ballast. She is a double-deck vessel, 100 feet long, 10 feet beam and her registered tonnage is 977. She is owned by Capt. Jacobson, her commander, who built her in Maine. Her hulling port is Avend, Norway.

Beaches from Long Beach say that there is very little prospect that the vessel or any part of her can be saved, as she is rapidly going to pieces.
