HANDCUFFED AND BEATEN.

Peddler Brown Has an Exciting Time in a Brooklyn Saloon.

One Assault Sent to Jail and the Other Held.

Justice Walsh, in the Butler Street Court, Brooklyn, this morning sentenced William Davidson, aged thirty, an insurance agent, of 481 Fifth avenue, to ten days in jail, and held James O'Mara, aged nineteen, of 478 Fifth avenue, for sentence until Monday, both men being charged with assault by Casper Brown, a peddler, of 19 Christie street, New York.

When Brown appeared in court this morning he was excited, and, waving his hands about in the air, declared that the assault should be sent to jail for life.

He showed the Judge his wrists where the two men had clapped handcuffs on him, and then pointing to an abrasion of his neck said that he had been beaten him.

Brown said that last night he entered Evered's saloon at 478 Fifth avenue, to sell some goods.

O'Mara, he says, jumped on him as he was leaving, and Davidson held the peddler O'Mara a pair of handcuffs on his wrists.

When the peddler broke away from the two men and ran to the nearest station-house.

Brown had to wait an hour before O'Mara was caught, when the handcuffs were removed. O'Mara had the key.

When arraigned before the Judge both men pleaded guilty, and O'Mara admitted that he had been arrested before.

The men denied that they handcuffed the peddler in order to rob him, but said it had all done for a joke.

RESTAURANT SPIRITUALISM.
