At intervals of fifty or sixty hours he wakes up and speaks a few words, but again, at such times he calls for bread or milk. These are the only words he has time to do this his catalepsy returns, and he lapses into his former state. When he awakens he uses his arms and is able to move.

Dr. di Moise believes that Pasquale is conscious of all that is going on about him. His opinion was strengthened when he saw the doctor's brother made to him the other day.

Pasquale seemed to recognize him at once, and this had the effect of causing the little sufferer to speak. He merely ejaculated a few words, and then lapsed into a stupor. The brother has been sent for almost any position and will remain here for a long time.
