MULLER UNDER FIRE.

Cross-Examination of Dr. Meyer's Confessed Accomplice.

His Disgraceful Career in the West Freely Admitted.

He Admits that Part of His Previous Testimony is False.

Several women gained entrance to the Court of Oyer and Terminer this morning, and were deeply interested spectators when the cross-examination of Carl Muller, the confessed accomplice, was taken up by Charles W. Brook, in the trial of Dr. Henry C. F. Meyer, accused of poisoning Ludwig Brandt, alias Baum, to death with croton oil, anti-mony, arsenic and iron in March, 1892.

Muller is an informer, but it is not generally believed that any human being would become an informer and a State's witness, implicating himself in a foul murder, if no murder were committed.

Dr. Meyer says Muller's real name is Arnold Kirfel. The witness was known as August Winners in the conspiracy to defraud the insurance companies, the conspiracy which, it is charged, ended in the murder of one of the conspirators, Brandt, under the name of Joseph Baum.
