At the Park Board meeting to-day a committee consisting of C. A. Hinton, E. J. Martin and George W. Ord, representing the property-owners of the north and south sides of Van Cortlandt Park...

The Commissioners asked the property-owners to furnish the Board with an estimate of the cost of the new thoroughfare, and promised to look over the ground later on.

Another committee was present to ask for the opening of a street to connect Riverside Avenue with Dan's Lane. This committee was told that if any of the \$100,000 appropriation was left over the completion of the work now progressing under it the street would be cut through.

The question of the High Bridge Park payers' Association, through H. L. Ackerman, presented to the Board a set of resolutions asking that some \$100,000 appropriation be used to improve High Bridge Park.

Commissioner Clausen, speaking for President Tappan, who was absent temporarily, caused some surprise by saying that there was very little of that appropriation left now.

USED BRICKS IN REVENGE?

Mooney Brothers Accused of Assaulting Instructor Robins.

He is in a Hospital with a Fractured Skull and May Die.

Joseph Mooney, seventeen years old, and his brother James, fifteen years old, of 113 Amsterdam Avenue, were arraigned in the Yorkville Police Court today on a charge of feloniously assaulting Arthur D. Robins, physical instructor of the Riverside Social Club, at 55 West Sixty-ninth Street.

Robins was in Roosevelt Hospital with a fractured skull, and Dr. Albert Knapp, the attending surgeon, sent a certificate to court saying that his patient was still in a dangerous condition.

Justice Voorhis at once committed the Mooney boys without bail to await the result of the injuries to Robins. James Mooney, being under sixteen years of age, was transferred to the custody of the Gerry Society.

Policeman Gannon, of the West Sixty-eighth Street station, found Robins lying along West Sixty-ninth Street last night at 11 o'clock. His face was smeared with blood and at first the policeman did not recognize Robins.

The Watsons, who removed the boys from Robins, reached Roosevelt Hospital, where Robins was taken. Policeman Gannon identified the boys as the Mooney boys. He lives at 113 West Twenty-second Street, and has been employed as a physical instructor at the Riverside for the past five or six weeks.

When Policeman Gannon examined the neighborhood where he found Robins he picked up a brick called with blood. This is believed to have been the missile used on Robins.

The Riverside Social Club is composed of working men and boys of the upper west side. Up to a month ago they had been in good standing in the gymnastic department, and as was natural with boys of this class, they were somewhat unruly.

Robins, who came from Wood's Gymnasium, at Fifth Avenue and Twenty-eighth Street, had considerable difficulty in suppressing and disciplining the boys. Among the most troublesome, it is said, was Joseph Mooney, a gang of young boys in for rebukes of the sternest nature, which apparently had no effect, and which Robins finally was forced to expel the lad.

This is said to have so angered young Mooney that he decided to injure his big brother Joe to lick the instructor. That was on Monday night, and last night the police saw the boys in the neighborhood of the club-house, and the crowd were both of the police and the boys.

Mooney brothers that their arrest was deemed necessary. They were taken to the police station just before midnight at their home.

In court to-day both of the Mooneys declared their innocence, and insisted that a lad named Mike McNulty, for whom the detectives of the West Sixty-eighth Street station are looking, was the guilty party.

At the hospital it was said that Robins' skull was fractured, and he was in a precarious condition.
