Hay was before Inspector McAvoy at Police Headquarters this morning, as were also the complaining witnesses, Jacob Klein, Pauline Klein, his sister-in-law; Mary Klein, the latter's daughter; and Otto Elsoasen.

Mrs. Klein told the Inspector that Detective Hay found Jacob Klein, who is an invalid, lying in front of their door, 62 Eighth avenue, on the evening in question. He abused the old man, and when she went out to interfere for her brother-in-law, Hay assaulted her. Hay was intoxicated, she said, and when Mary Klein, the daughter, answered the detective knocked her down and struck her on the breast.

Hay, she then stated, arrested Jacob and Pauline Klein, Elsoasen, who is engaged to be married to Mary Klein, followed.

At the station-house Hay made a charge against Elsoasen and locked him. Several
