### FIVE BOYS DIE BY POISON.

And Seven Other Inmates of a Tarrytown Home Are Seriously Ill.

### ATE SUPPOSED FLAGROOT.

Picked the Poisonous Stuff Out of a Trench Which Laborers Were Digging.

### REMEDIES PROMPTLY APPLIED.

But in Spite of Physicians' Efforts the Little Sufferers Died in Great Agony.

TARRYTOWN, June 5.—Five young boys, inmates of the Roman Catholic Institution of Mercy at Wilson Park, just back of this town, died in terrible agony during the night. They had eaten a poisonous root while they were digging yesterday afternoon. The victims are: JAMES FORESTAL, ten years old; JOHN CALLAHAN, aged ten years and three months; THOMAS PARMORE, aged ten years and five months; EDWARD POWERS, aged twelve years; JOHN DONNELLY, aged twelve years. Seven other boys also ate the root, but not in such quantities as those who died. John Harvey, however, is likely to die. The two of the ill boys are named O'Day. The names of the others the Sisters refuse to give.

The prompt arrival of Dr. Furman, Fleming and Contant, who were summoned from Tarrytown, saved their lives. They are convalescing.

The Institution of Mercy is a big gray stone building, with room for over 300 inmates. It shelters orphan boys who have lost either parent. They range from a few months to fifteen years in age.

A number of the boys were out playing yesterday afternoon on the grounds of the Institution. The grounds are being dug for drainage purposes. As the men threw up the dirt the boy Donnelly discovered pieces of a rough root. It resembled the sweet flag root, which grows in marshy lands, and Donnelly evidently was deceived by the resemblance.

He picked up a piece and chewed it. The children died in the night. The other children dove into the heap of fresh earth and soon a dozen were chewing the root with great relish. A few hours later the youngsters who had eaten the roots, were seized with pain about the heart. Physicians were hurriedly sent for, and though Drs. Urman and Fleming responded promptly, they were unable to save five of the boys. Young Donnelly was in line with the other boys, about to go into supper at 5 o'clock, when he was seized with convulsions, fell to the floor and died in a few minutes.

The physicians worked vigorously all night and this morning on the other boys who were ill, and by noon all, excepting young Harvey, were pronounced out of danger.

The physicians obtained some of the root, and after examining it came to the conclusion that it was the root of a poisonous ivy. It resembles flag root, which is three-lobed, and has a rough bark on the outside and a pithy center. It tastes something like slippery elm.

Coroner Adgar, of Peekskill, was notified, and this forenoon impelled a jury to hear the matter. The coroner has ordered an autopsy to be made in each case. Undertaker Vanderbilt took charge of the five bodies, and will bury them at the expense of the institution.

The coroner's jury returned a verdict to the effect that the children had died of paralysis of the heart from eating a poisonous root.

As soon as young Donnelly died, the Sisters sent for the Mother Superior of the House of Mercy, at 1075 Madison avenue, New York City, of which the Tarrytown institution is a branch. She arrived early this morning and took charge of the dead boys.

Of the dead boys, Parmor, Powers and Donnelly were orphans. Callahan and Forestal had fathers living in New York.

The institution is situated on a plot of thirty acres, and although opened recently, is already a beautiful retreat. It is in charge of the Reverend Mother Superior, who has under her seventeen Sisters of Mercy.

**ALL NIGHT IN A CELL.**  
Innocent Woman Arrested for Trying to Collect a Bill.

Homer Clark said Mrs. Lee Moutt was Drunk and Disorderly.

Case Dismissed on the Evidence of the Arresting Officer.

Mrs. Margaret Le Mott, a well-dressed woman, thirty-one years old, who keeps a florist establishment at 436 Fourth avenue, was a prisoner in the Yorkville Police Court to-day on a charge of drunk and disorderly conduct, preferred by Homer Clark, the leasee of a stylish boarding-house at 30 Broadway park.

The woman was arrested at 5 o'clock last night in Mr. Clark's house by Policeman E. J. Farrell, of the East Twenty-second street station, and although the officer assured Justice Voorhis in court this morning that the woman was perfectly sober, she was locked up all night in a station-house cell.

Lawyer Wright, who is a boarder in the house, summoned the officer to the house, and when she refused to leave Mr. Clark ordered her arrest on his charge of drunk and disorderly.

Mrs. Le Mott told his Honor that she had never drunk anything intoxicating in her life. She said that she went to Mr. Clark's house for the purpose of collecting a bill of \$4.35 from his wife for flowers, which, she said, was long overdue. She saw Mrs. Clark, who asked her to wait, and she would get it.

She waited, but Mrs. Clark did not return. This made her indignant, and she said something about people not paying their bills being swindlers. A boarder then approached and requested her to leave. Mrs. Le Mott said she came there to collect the money, and proposed to get it.

Mr. Clark, who is said to be a Custom-House Inspector, then came to her and ordered her to leave. She again refused, and then sent the lawyer for the policeman.

When Officer Farrell arrived he found Mrs. Le Mott seated in a chair in the hallway. She was not drunk, he said, but seemed somewhat excited. When ordered to leave the officer said he had no right to do so.

Mr. Clark ordered her arrest, saying that she had refused to pay for the flowers. Farrell was then compelled to take her into custody, although he declares she was not drunk.

When the case came up in court Clark had the lawyer and an actor to corroborate his story.

The actor was Jake Dohlin, a well-known comedian, formerly with Frohman's Bijou Theatre Company. He told Justice Voorhis that she was a virago by her actions. The complaint was dismissed.
