It was right in the middle of the bridge where the cables swing low. Smith ran shouting towards the man, but no attention was paid to him.

The stranger leaped away the flimsy hand rail, climbed to the cable and swung into the air.

The body turned over and over in its descent and struck full upon its stomach with a great splash.

CLOSE TO THE MARK. The Heat Record for June 22 Is 91 Degrees, Made in 1888.

Weather Brewer Dunn Expected This to Be Broken To-Day.

Uniform Temperature All Over the United States at 8 O'Clock.

The hottest previous June 22 in the signal service records was in 1888, when the temperature reached 91 degrees.

Weather Brewer Elias B. Dunn, at the Equatorial Building this morning declared that to-day would be a "scorcher" and that there was no prospect of cooler weather to afford New Yorkers a breathing spell for several days to come.

A most remarkable occurrence in weather conditions, said Mr. Dunn this morning, "is that all the eastern section of the country west of the Mississippi River and as far south as the Gulf of Mexico the temperature at 8 o'clock this morning was almost uniformly 78 degrees.

At 8 o'clock this morning the mercury in Mr. Dunn's thermometer recorded 79 degrees, and at 9 o'clock the thermometer had crawled up 3 points.

The temperature at 8 o'clock in various parts of the country was as follows: Boston and Albany, 76; Chicago, St. Louis, Cincinnati, Jacksonville, Cairo, Memphis, New Orleans, Montgomery, New York, 78; Philadelphia, 79; St. Petersburg, Baltimore, Indianapolis, all 78 degrees.

The weather is slightly cooler west of the Mississippi. The coolest spot is at Roseburg, Ore., where it registered 67 degrees.

WASHINGTON, June 22.—Senators Harris and Aldrich were in conference to-day, and soon after they separated both expressed the opinion that the Senate would conclude the consideration of the tariff bill in committee of the whole before the close of the day tomorrow, and that the bill would be disposed of and ready for return to the House before adjournment on Tuesday.
