

OTHER TUGS IN NO DANGER. Capt. Dick Thinks the James D. Nicol Was Not Properly Loaded.

TUG PILOTS AS WITNESSES. Wreckage Picked Up by "The Evening World's" Tug Force - Fully Identified. DRUNKENNESS, SAYS HYDE. Nicol's Captain Explains Why Passengers Were Drowned While the Crew Escaped.

The investigation to ascertain the causes leading to the wrecking of the tug James D. Nicol was continued before Capt. James Fairchild and Thomas Barrett, of the Bureau of Inspection of Steam Vessels, at 10:30 o'clock this morning in room 154 at the top floor of the Federal Building.

James C. Halpin, assistant superintendent of the Reeves Towing Company, was the first witness examined. "I made the arrangements with Mr. Kirschner, of the Herring Fishing Club, for the use of the tug," he said.

"I did not tell Mr. Kirschner that the tug could be chartered to carry sixty-five persons. My understanding is that he told me that there would be from forty to fifty people in the party."

"The witness said that the only instructions given to the captain of the Nicol were to go to East Fifth street and take a party on board and collect \$40. No instructions were given to the captain as to the number of people he was to take on board."

"Did any of the officers of the Nicol report to you at any time that she was unseaworthy?" "No, sir."

Joseph Slatery, pilot of the tug, testified that he was the last to see the Nicol at the time of the disaster. "The equal raised the big sea and made it pretty bad sailing at the time. We picked up thirty-four of the survivors of the Nicol."

"All crowded to One Side." "Well, the passengers were all crowded to one side of the tug, and when she shipped a heavy sea, she was not able to right herself."

"How did the passengers on the Bayre behave?" "Admirably. They distributed themselves evenly over the tug."

"The witness said that the Bayre was heading for the Highland lights, and the Nicol was just ahead."

FRANCE SOFTENS TO WILHELM His Clemency to French Officers Leads to a Better Feeling.

Republic Takes Another Step Towards Conciliation with Rome. (By Associated Press.) PARIS, July 2.—All the newspapers of this city eulogize the courtesy and civility of Emperor William of Germany in ordering the release from prison of Lieutenants Dagon and Malevas, two French officers, who were convicted of spying upon the fortifications of Kiel.

It is too early to estimate the effect upon the relations between France and Germany which this coup upon the part of Emperor William will eventually have. But its effect has been to cause an outburst of gratitude towards Germany, which may pave the way for much better permanent feelings.

Germany, since her spat with England upon the Congo treaty question, has been feeling much more sympathy for France than for years past, and the murder of President Sadi-Carnot seems to have increased the growth of friendship between the two rival nations.

It is announced this morning that the French Government has annulled the order issued in April last suspending the stipend of the Archbishop of Lyons and that he is to be immediately paid his salary. This, evidently, is another step towards conciliation with Rome.


