

EHRLICH'S QUANDARY.

He Hasn't Decided What to Do with Lawyer Joseph.

Mrs. Goldenson Says the Latter Got \$500 "to Fix the Judge."

The Accused Attorney's Brother Writes a Letter.

Chief Judge Elmon M. Ehrlich, of the City Court, who tried both the suits of Mrs. Sarah Goldenson against the Bowery and Dry Dock Savings Bank, which have given rise to a charge on the part of Mrs. Goldenson, obtained \$500 from her under a pretext that it was to "fix the judge," arrived at his office much earlier than usual to-day.

Judge Ehrlich was in the country yesterday when the motion was made before Justice Andrews, of the Supreme Court, to compel Lawyer Joseph to return the money to his former client, and knew nothing of the matter until he saw it in "The Evening World." An "Evening World" reporter saw Judge Ehrlich a few minutes after his arrival in his chambers.

"I really know no more about this matter than you do," said Judge Ehrlich. "I have just gone over the papers in the two suits and find the stories published of the suits and the deposition were correct. There were no witnesses put on by the defense in either of the suits, and from the evidence I could not have decided except as I did."

"Of course I know nothing of the case. I do not even know that Lawyer Joseph told her it was for the judge. He denies having done so."

"I have, since my arrival, been thinking what I can do in the matter. If I bring Lawyer Abraham Joseph before the General Term there will be the unsupported charge of the woman against my sworn denial."

"Here is a letter I have just received from Herman Joseph, the brother whom Abraham Joseph claims was retained by Mrs. Goldenson and paid the \$500 for 'that purpose.'"

Lawyer Joseph's letter, after expressing surprise and indignation at the charges which concern Judge Ehrlich, says: "I am far from endorsing the conduct of my brother in this or any other matter, and this incident has proven a life-long lesson to me, never to have any dealings with my brother in any way to associate myself with him. His conduct by reason of his own acts has always been open to criticism."

Lawyer Abraham Joseph was at his office, 273 Broadway, for a few moments this morning, but when an "Evening World" reporter called he was told that Mr. Joseph had gone out and that his return was uncertain.

Lawyer George H. Epstein said he had nothing to say until the affidavits of his client were submitted to him on July 7 by a power explosion while at a picnic. It is doubtful if he will survive the accident.

Injured by a Powder Explosion. (By Associated Press.) ST. LOUIS, July 6.—William Murphy, son of E. J. SAYS SHE'LL MOVE, NOW.

Mrs. Hawley Chapman Admits the Absorption of a Cocktail. Conspicuous among the "drunks" lined up in Jefferson Market Court this morning was a tall, finely proportioned young woman, clad in a chic costume of Summer silk and with her shapely white fingers covered with jeweled rings. She carried herself with a queenly air and utterly ignored her surroundings.

Policeman Jordan arrested her about 9 o'clock last night while she was surrounded by an admiring throng of "Tenderloiners," who were watching her do the "Kangaroo dance." Three policemen were necessary to take her to the station-house.

Arriving there she gave her name as Cora Shotwell, said she was sixty-eight years old and had had sixteen husbands. Policeman Jordan said that he was sure that his prisoner was Mrs. Cora Clifford Chapman, wife of Geoffrey Hawley Chapman, who is an institution for the insane on Long Island.

In court this morning the young woman sat demurely until Justice Voorhis told her she had been preferred against her. She had nothing to say, and smiled again when told that she was fined \$5.

Lawyer H. W. Leonard, of 128 Broadway, told the fine and left the courtroom with his client.

Asked by an "Evening World" reporter if she cared to make any explanation of her rather unorthodox conduct, the young woman laughed a rippling laugh, then shook her head, and said: "There is nothing particular to say," she replied. "I had only taken one cocktail with me."

Then, evidently changing her mind, she said: "Oh, well, I guess I was very much intoxicated."

Asked if she was really Mrs. Hawley Chapman, she replied: "I am Mrs. Hawley Chapman and I live at 147 West Twenty-third street. I shall move now, however."

Lawyer Leonard said that his client was Hawley Chapman's wife. She had, he said, been connected with a party of friends and had imbibed too freely. She became separated from the party on her return to the city last night. As to the occurrences just previous to her being landed in the West Thirtieth street station, the lawyer says his client knew nothing.

TO SUCCEED MAJOR BULLARD.

Alfred Lucas Likely to Be Chief of the Sanitary Squad.

Alfred Lucas, tea and coffee inspector and Chief Clerk of the Bureau of Contagious Diseases, will, in all probability, be appointed to temporarily fill the position of Chief of the Sanitary Squad of the Board of Health, made vacant by the death of Major Willard Bullard.

ATTACKED BY A WOMAN.

Hotel-keeper McKeon Has His Former Love Arrested. ROCKAWAY BEACH, July 6.—Joseph Weller, of New York city, was arraigned before Justice Smith yesterday and remanded until Wednesday under \$1,000 bonds for having assaulted Charles McKeon, proprietor of the Hotel Arlington, on Pier avenue. McKeon is a native of New York, and is well connected.

Up to two years ago the woman, it is alleged, was known as McKeon's wife. She occupied a handsomely furnished cottage at Lawrence, L. I. When they separated, in the Spring of 1892, McKeon came here and opened the Arlington. He engaged William Campbell and his wife, the latter to act as housekeeper and Campbell to tend bar.

McKeon and Mrs. Campbell were seen out driving frequently and the gossip began to talk. Campbell, after a wordy fight with McKeon, left him and opened a hotel at Rockaway Park.

Several weeks ago he brought suit against McKeon for \$2,000 damages for alienation of his wife's affections. The suit is on the calendar of the City Court, Brooklyn. Jerry Wernberg has been engaged to prosecute the case.

Yesterday morning Josephine Welles visited the Arlington accompanied by a man. She created a scene there and struck McKeon in the face. He called a policeman and had her locked up. She was well dressed and wore many diamonds.

Her companion took the train for New York, and returned a few hours later with \$1,000 in bank notes, which he deposited as a guarantee that Mrs. Welles would not leave the city. McKeon, when seen by "The Evening World" man, admitted having lived with Mrs. Welles, but denied the accusation of Campbell.

LARRY KAINE DEAD.

Divorced Henchman Fell from a Window Three Weeks Ago. Larry Kaine, a well-known character of the Fourth Ward and a henchman of Al Capone, died early this morning at his home, 49 Monroe street.

Kaine fell from a window early one morning about three weeks ago, after returning from a night of conviviality in the basement two hours later with four prostitutes and several injuries. His death had been daily expected since by the attending physicians.

Obituary Notes. Robert O. Buhler, thirty-seven years old, of the law firm of Lawrence & Buhler, of the Equitable Building, died in the New York Hospital of apoplexy last Wednesday. A widow and one child survive him.

George Harper Bisher died at Greenwich, Conn., yesterday. He was a member of the New York Cotton Exchange and several New York clubs, and a grandson of John Harper, one of the founders of the city. Bisher died early this morning at 12:09 P. M., at his late Greenwich home.

Judge McCarthy, of the City Court, will deliver an address and Judge McKeon, of the Superior Court, will close the exercises.

DIDN'T SNUB CROKER.

Dr. Jenkins Says Treasury Officials Didn't Get the Chance. In reference to the statement in the morning papers to the effect that Dr. Jenkins, as Health Officer of the Port of New York, had been refused permission by the Treasury officials in Washington to take Mr. Croker from the Majesty at Quarantine on Wednesday, Mr. Jenkins has this to say this morning to an "Evening World" reporter.

"The statement that I was refused permission to take Mr. Croker from the Majesty at Quarantine is absolutely false. I did not receive any telegram from any Treasury official on that subject."

"Mr. Croker had no desire to leave the Majesty at Quarantine. He preferred to stay there until he had been released from the city on his boat. He could have taken him off without asking any one's permission. I should have expected it as a return for the many courtesies extended by me to the Treasury officials."

Further than this Dr. Jenkins refused to discuss the matter.

ELEVATOR COMPANY FORMED.

Will Succeed Corporations Which Failed a Year Ago. (By Associated Press.) DULUTH, Minn., July 6.—The reorganization of the Lake Superior and Union Improvement Elevator Companies, which failed last July, was completed yesterday morning in New York. A new company is formed under the laws of New Jersey, with a capital of \$1,000,000. The various interests are united for the control of the two terminal elevator companies at Duluth and the Northern Pacific Elevator Company's houses in Minnesota and Dakota.

Old stockholders have subscribed \$60,000, and this, with \$90,000 dividends from the receiver and the rest from bond sales, will operate the concern. The State Trust Company, of New York, will be trustee.

Wife-Murder and Suicide.

(By Associated Press.) GREEN RIDGE, N. Y., July 6.—John Titworth, a farmer, living five miles north of this place, yesterday shot and killed his wife. Immediately afterwards he blew his brains out. It is thought to have been insanity. They leave a family of five children.

Negro Lynched in Mississippi.

(By Associated Press.) MEMPHIS, Tenn., July 6.—George Prand, a negro, charged with attempting to assault a white woman, was lynched by a mob at Fulton, Miss., early this morning. He was found hanging from a tree in the town square.



MURDERED IN A CORNFIELD.

Robbery Not the Motive for Killing a Tailor-Barber. (By Associated Press.) TABLEQUAH, I. T., July 4.—A horrible murder was committed in this city last night and the coroner's jury has been vainly trying to get a clue to the perpetrators. George Craft was the victim, and his dead body was found hidden in a little bunch of corn in the northern part of the city with his skull crushed and his neck broken. His watch and \$20 in cash were found on the body, showing that he was murdered for other purposes than robbery.

Footprints leading to and from where the body was found show that two persons were parties to the crime. Craft was a barber, about forty-five years old, and came here several years ago from St. Louis, where his relative reside.
