Government After George Carson and "Sid" Yennie, Notorious Crooks.

REWARD OF \$500 OFFERED.

Charged with Aiding Killoran, Allen and Russell to Escape.

ARCHIBALD IS THE NEW WARDEN.

Sheriff Tamsen Names a Grace Democrat to Succeed Raabe, Deposed.

There is a growing suspicion in the minds of the Federal authorities that the persons who aided the three criminals, Allen, Russell and Killoran, to escape from Ludlow Street Jail, were men just as well known in criminal history as for whom the United States marshals and detectives have long been searching.

That other men were interested with the three named in the robbery of post-offices throughout the country was known from the first, but until the present time their names were carefully guarded.

Now, however, the marshals have dropped their secrecy and not only do they give the names of the men wanted, but they offer a reward of \$500 for their capture.

The men they suspect of having aided in the escape from Ludlow Street Jail are George Carson, alias George Hayward, and "Sid" Yennie, alias "Sid" Manning.

These men, it is claimed, were with Killoran, Russell and Allen when the post-offices in Springfield, O., and Hoboken, N. J., were robbed. All efforts to trace them failed, however, and it is thought that they may have been here, if so, their presence would account for the large amount of money which the three criminals possessed before their escape from the jail.

Carson and Manning were adept at the art of "making up," and could change their appearance so that scarcely anybody would recognize them. They may even have visited the others in the jail and carried in the pistols.

A number of men did visit the prisoners in the jail, four being the names before the escape, despite the statements of ex-Warden Raabe to the contrary. Two of them were notorious characters, whose pictures adorn the Rogers' Gallery.

The names of the men who were with the escape when the Federal Grand Jury begins its investigation to-morrow.

Sheriff Tamsen, ex-Warden Raabe and all the keepers and girls employed in the jail have been subpoenaed. Sheriff Tamsen says he is not in the least excited by the prospect of a reward of \$500, but he can imagine for a moment that he was going to be indicted.

The new warden of the jail, James P. Archibald, is expected to-morrow. The case was adjourned until Saturday. It is the first instance on record, where a man who had been deposed as warden of a jail, was again appointed to the position.

United States Attorney Shields, before whom the examination of Killoran, Russell and Allen was conducted, returned to the city today, having been absent since before the Grand Jury.

He said the question that puzzled him now was the mode of procedure to be adopted to-morrow, when the case is again called before him for examination. The last time the prisoners were brought to the city, they were taken to the city hall, where they were made for the prisoners' escape was committed, and while their examination will proceed.

United States Attorney Macfarlane said that the case would probably be decided on Friday. He said he had decided what formal course to pursue, and that the only thing certain was that the prisoners had to be left alone.

At 10 o'clock, July 9, information was received in this city last night to the effect that Chief Postmaster Wheeler had ordered the arrest of George Carson and "Sid" Yennie, notorious New York crooks.

Escaped from a Hospital. Policeman McNeill, of the oak street station, who was shot in the eye by a prisoner on July 4 and who was removed from the city and taken to New York Hospital, yesterday suffering out of the reception ward and wandered away.

When his absence was discovered a general alarm was sent out. A fellow-officer met and captured him in Chatham Square. He was taken to the hospital, where he was lying in a man with a bullet in his head, a bandage over his eye and wearing a policeman's helmet, with civilian's clothes, went so far without being stopped.

McNeill was delirious. He was taken to his home, 72 Oliver street, where the hospital authorities will investigate the hospital carelessness that allowed such an escape.

McNeill was removed this morning to the Gouverneur Hospital.

Police Surgeon Hamrick called at McNeill's home this morning and took him in his carriage to the hospital. The doctor said he was suffering from low delirium, and while waiting in the reception-room the idea of home possession came into his mind.
