LABOR NEWS.

Corporation Counsel John Whalen has been thanked by the unions of drivers, bootmen and sweepers of the Street Cleaning Department for enforcing the prevailing Rate of Wages law. At the last meeting of the organizations resolutions were adopted thanking him for the active and friendly interest he had taken in tending to promote the interests and welfare of labor.

Mr. Whalen was much impressed by the action of the unions and has said that no conflict can come between labor and the city of New York.

The Executive Board of the New Jersey Federation of Trades and Labor Unions will communicate with all farmers' organizations and urge them to affiliate with the mechanics unions in forming a blanket of legislators who voted against the resolution calling for the election of United States Senators by popular vote.

At the recent convention of the International Union of Steam Engine Drivers, the Executive Board of the organization was changed. Among them was the raising of the per capita tax to the central body from eight to ten cents and the combining of the office of the secretary and treasurer.

The C. E. U. has decided to cooperate with D. A. O. of the K. of L. and other fraternal bodies in the agitation which has been started against Chinese labor and patronage. Congress will be asked to amend and extend the Chinese Exclusion act.

A conference will be held in West Hoboken Sunday for the purpose of effecting an amalgamation between the Workers by Union, No. 21 and 23, and the delegates of the American Federation of Labor was instructed to further the movement of all labor organizations. The plan goes through more than \$1,000,000 will be raised.


