

MINN. STARTS FOR NORTHWEST

Senator's Biggest Fight to Be Made in South Dakota.

CHICAGO, Oct. 15.—Chairman Hanna, of the Republican National Committee, started on his tour of the Northwest today, accompanied by Senator Frye, of Maine, Mr. Dolliver, of Iowa, and others.

The party travels on a special train, and will make the first important stop at Waukesha, Wis., this afternoon. From Waukesha the party will move on to Madison for a night meeting.

From there the party will proceed to Stillwater, Minn., where Senator Hanna and Senator Frye will begin the second day of their tour. The itinerary includes four or five stops in Minnesota.

STEVENSON IN NEW JERSEY.

Republican Strongholds Invaded by Bryan's Running Mate.

Adlai E. Stevenson is making a whirlwind canvass of the Republican First Congressional District of New Jersey today.

The district comprises the extreme southern end of the State and has all Democratic members, but this year Col. George Pfeiffer is the Democratic candidate for Congress against Congressman Loudenlager, and he hopes to win.

This morning Mr. Stevenson came direct from Wilmington, Del., escorted by a sub-committee of the New Jersey Democratic committee, whose members included Judge Howard Carrow, Secretary R. E. Hall, Fredell and Senator William Keyser.

Mr. Stevenson began his tour of the State at Bridgeton, where he was greeted by a large throng, many Republicans being among those who greeted him. Most of the Democrats suspended business during his stay.

M'COLLAGH TO POST CARDINER

Elections Superintendent Has a Full List of Dives.

Supt. McCullagh and his staff of clerks were busy today with the duplicates of the registry list sent in by the acting tabular for inspection by the inspectors and for purposes of the Superintendent.
