


STRANGE FEATURE IN RIVER MYSTERY

In seeking to establish the identity of the beautiful and richly clad young woman whose body was found floating down the East River yesterday, the police have come upon a strange coincidence in laundry marks.

6,000 "FINEST" IN POLICE PARADE.

Thousands Through the Streets to See the Most Brilliant of Marches in the History of the Department.

The most brilliant and satisfactory police parade in the history of New York marched up Broadway and Fifth avenue this afternoon.

It is no exaggeration to say that the visitors were awed as column after column of neat, sturdy blue-coats swept by an army of 6,000.

Of course the crowds were out, packing the sidewalks from curb to building line, banging from windows and roofs, and roosting on trucks in side streets.

The old "warhorse" Inspector Cortright, got the start of the enthusiasm as he rode up at the head of the line.

New York's blue-coated guardians of the peace, resplendent in new uniforms and drilled as they never were drilled before, showed off before the people who foot the bills to the extent of millions each year.

Months ago, when it was known that the Chief's Convention was to be held in this city, William S. Devery, then Chief, now First Deputy Commissioner, issued an order to the force to drill as they had never drilled before and to prepare finer uniforms than ever for the annual parade.

The visiting chiefs saw the greatest police show as to glitter and military precision that ever was on exhibition in this country.

Gen. Cortright's staff consisted of Inspector William W. McLaughlin, of the Bronx; Inspector Patrick H. McLaughlin, of the Borough of Brooklyn; and Inspector Elias P. Clayton, of the Borough of Queens, as chiefs of staff.

STOCKS REFLECT LONDON'S BOOM.

Prices Scored Gains of 1 to 3 Points on Heavy Buying.

In many respects the market showed decided improvement at the opening today. Prices were fairly buoyant, reflecting London's advance over the holiday and the trading was on a large scale.

The initial figures scored gains extending to 2 points in Atchafalpa common and Union and Canadian Pacific.

The opening dealings in three issues were 1,000, 500 and 2,000 shares respectively. The support did not lag after the opening, in fact the buying increased and prices extended the opening gains to 3 and 4 points.

The steel stocks were especially active, 15,000 shares of the common being purchased at a net gain of 1 percent. 5,000 shares of the preferred sold at 96 compared with 94 7/8, Tuesday's final figure.

The boom was confined chiefly to the railroad group, though the industrial issues were by no means dull. Sugar, copper and iron and steel were all up 1 point or more.

After the first half hour's trading prices were steady. However, a retrograde movement was due to realizing profits and in the afternoon the reaction wiped out the early gain.

The advance in the more rapid during the second hour prices rose one-half percent at a time. Buying was brisk and indiscriminate, though the stocks were slightly favored.

Atchafalpa common was most liked at a gain of 3 points, selling at 97 1/2. American Tobacco was 2 1/2 percent, Colorado Fuel & Iron 1 1/4, General Electric & Missouri Pacific 1 1/4, Peoples Gas and Telephone and Iron 1 point. In the steel stocks also continued to advance on insignificant support.

The closing was strong and active, with prices at the best figures for the day. The total sales of stocks today were 1,200,000 shares.



PROMINENT AT KENNEDY TRIAL.

Counsel for Defense Says that She Will Aid Materially in Establishing an Alibi for Accused Dentist.

The defense of Dr. Kennedy opened this afternoon with the accused dentist's counsel confident that he would present to the jury the strongest case yet made in favor of the man who is charged with killing Dolly Reynolds in the Grand Hotel.

Lawyer Moore says she will swear that she saw Dr. Kennedy on the evening of the murder, and that he was not dressed as witnesses for the prosecution, who say they saw him in the dining-room of the hotel, described him.

Several important handwriting experts testified at the trial today. Their testimony was similar to that of other bank employees who testified earlier in the week.

WON'T ACCEPT CUBA'S VIEW.

President and Cabinet Decide New Constitution Won't Do.

WASHINGTON, May 31.—The President and the Cabinet today at their meeting decided that the action of the Cuban Constitutional Convention was not a "substantial" compliance with the terms of the Platt amendment.

One of the most objectionable features of the interpretation is the addition of the words saying that the action of the United States is an amplification of the Monroe doctrine.

It is stated that the earnest desire of the President is to retire from Cuba at the earliest possible moment consistent with the best interests of the people of the island and the future relations between the new Government and the United States.

The problem is whether withdrawal under the amended Platt law will accomplish that result.

SHEVLIN WANTS 1,000 STRIKE NEW TUNNEL. IN CHICAGO.

But Thinks Van Wyck Does Not Approve Present Plan.

James Shevlin, Hugh McLaughlin's representative in the Brooklyn Democracy, came to Manhattan this morning for a conference with Mayor Van Wyck regarding the Brooklyn tunnel scheme.
