

MANIAC TRIES TO KILL FAMILY

Charles Socko, in a Religious Frenzy, Declares God Has Ordered Him to Murder His Wife and Children.

SEIZES AN AXE TO OBEY THE COMMAND

Six Policemen Finally Overpower Him After a Desperate Struggle and He is Removed to Bellevue Hospital.

The combined strength of six policemen was required to hold Charles Socko to-day when he became suddenly insane and attempted to slay his young wife and two children at their home, No. 314 East Thirteenth street.

Socko, who is a man twenty-five years of age, hardworking and industrious, became very religious recently, and last night he seemed in an excited condition. After returning from prayer-meeting he retired to his room, but early to-day his wife heard him screaming in the rear room of the apartment.

She saw him brandishing an axe and heard him declare that he had been commissioned to kill his entire family. She grabbed up her sleeping children and ran to the front room, barricading the door after her.

Socko's wife attracted the other tenants in the house. They ran to his apartments, but the man met them at the head of the stairs and stood with raised axe ready to strike the first that came within reach. The men and women fled to the street and some ran to the Fifth street police station for aid.

Policeman Harry Burke was sent to the house. On his way he met Policeman Thomas Harney. The two arrived at Socko's apartments and found the man in the hall. He had beaten down a door leading into the room in which Mrs. Socko had first looked herself and children, and was even then attacking the door of a second room where the mother and children could be heard screaming for help.

The policemen dared not venture up the steps for fear of their own lives. Both had pistols and clubs drawn, but they did not want to use them until a last resort.

The screams of the mother and frightened tenants attracted four policemen off post, and they came to the assistance of Burke and Harney. The policemen made their way up the fire-escape and attacked Socko from the rear.

No sooner did the policemen grapple with Socko than the latter showed superhuman strength. He dropped his axe, and with his fists attacked the six policemen with might and main. He hurled them to the floor and, biting and scratching, he was almost a match for their combined strength.

After a struggle lasting fifteen minutes the man was overpowered. An ambulance from Bellevue Hospital was called and an attempt was made to get Socko into a strait jacket. Again the policemen had all they could do to overpower him. On the way to the hospital the man screamed loudly and declared that his being kept from killing his wife and children was an sin which his captors would have to answer to God.

Mrs. Socko was in a state of collapse when she was rescued. She said that her husband had become a religious fanatic recently and that she had a gun to fear that he would lose his mind.

HIT BY TRAIN WHILE DRIVING. Two Men Injured in Clash Clung to Wagon as It Was Dragged Along. Jean Pettit, thirty-five years old, and Charles Bedell, thirty-nine years old, are in the Nassau Hospital at Mineola, L. I., suffering from injuries received at Garden City, where a wagon in which they were driving was run down by train No. 118 of the Long Island Railroad.

The horses broke away from the wagon and ran down the road. While the wagon, with Pettit and Bedell clinging to it, was dragged, the feet of the engine. Both men were unconscious when picked up. It was thought Pettit's skull is fractured. Bedell has a severe scalp wound. The horses were not stopped until they reached Hempstead.
