SICK ROWERS ARE BACK IN THEIR BOATS

Adding Syracuse and Georgetown Men Are Able to Take Part in Day's Practice.

POUGHKEEPSIE, June 23.—Stroke, a disease of Syracuse, whose sickness last night caused some uneasiness, was able to row today.
