"He is rich; he has everything, while I have nothing. My husband is probably worth \$15,000. He is well known about New York, but his friends seem to be shielding him from me."

"When I can't even send my child to school for fear that she will be kidnapped, she is not even allowed to go to the hall without my mother going with her. For the past year I have noticed suspicious looking men hanging about our apartments. Some time ago a woman, who claimed she was an actress, went to the office of my lawyer and told him that she would receive a large amount of money if she could obtain possession of my little girl. Since then I have guarded her very closely."

Works Hard to Live. For ten hours every day Mrs. Wilkinson works behind the counter of a department store. Out of her salary she supports her child and her aged father and mother. Up to the time of her marriage she lived with her parents at Madison avenue and East Eighty-sixth street. That was just several years ago and she was only twenty years. Then she met Wilkinson, a handsome fellow, but fifteen years her senior. About a year after having taken a full course in medicine, although he never practiced his profession.

"I thought Jack was the finest man in the world then," said Mrs. Wilkinson. "I loved him devotedly, and he always appeared to love me. One day we were out driving, and he always drove without the consent of my parents, we were married. About a year after our marriage my child was born. Jack did not like children, and after that he seemed to tire of me. About three days after little Gladys was born and I was lying in bed this man came to me and told me that he would have to rid of the child or he would leave me. When I refused to comply with his brutal command he left me in anger, and I did not see him for several months. Finally it was necessary for me to have him arrested on the charge of non-support. The case came up in court before Justice Deuel, and my husband was ordered to pay me six dollars a week for the support of the child. After a time his payments ceased, and he suddenly disappeared. NUNS ROBBED BY AID OF A SPY

Mother Superior of Ursuline Academy Reports Theft of \$240 in Cash.

Possessed of information believed to have been furnished by a spy installed in the Ursuline Academy, at Park avenue and Ninety-third street, a thief has robbed the institution of about \$240 secreted in a strong box. The police of the East Eighty-eighth Street Station have an accurate description of the thief, but have made no arrests.

The Ursuline Sisters gave a fair on the night of last Wednesday. The receipts were nearly \$800. Mother Superior Ursula had appointed Mother Ignatia treasurer, and the latter took the money to her room. It is believed that the thief, after receiving instructions from the spy, planned to get the receipts.

The thief gained admission to the academy on Thursday about 11 A. M. by representing himself as a workman. He said he had to repair the skylights on the top floor, where are the rooms of the Sisters. Mother Ursula had placed about \$240 in an iron box, which she had chosen the first time she saw the room. The thief entered her room, broke open the box and took the \$240 together with checks to the value of about \$700. The checks he threw under the bed.

It was apparently unknown to the spy that Mother Ignatia, whose room adjoins that of Mother Ursula, was the custodian of the receipts from the fair. That money was in Mother Ignatia's room when the thief made his raid.

1,000 LYNCHERS GATHER AT JAIL

Negro Guarded by Officers, Soldiers and Citizens Against Clamoring Mob.

SHREVEPORT, La., Feb. 20.—A mob of more than one thousand men gathered at the jail last night to lynch Charles Coleman, a negro, who attempted to assault Margaret Lear, a fifteen-year-old girl.

The girl struggled and screamed several times. The negro drew his pistol, and, prosing his muzzle against the girl's neck, fired. The girl fell unconscious and her assailant fled. Negroes who witnessed the act gave the alarm. Miss Lear died a few minutes after she was removed to her home.

The negro was apprehended by a posse led by Sheriff Ward, two hours after the murder, in a cabin near the scene of the crime. He said he was Charles Coleman, and had been employed in the shops of the Kansas City Southern Railway, in this city.

When it became known that the negro was in custody a crowd gathered around the jail, and at 9 o'clock last night more than a thousand men congregated with the avowed purpose of lynching the negro.

At midnight the crowd at the jail had dwindled considerably, and an attack is not now anticipated. One hundred armed men, composed of officers, soldiers and private citizens, are standing guard inside the building.

District Judge D. Bell addressed the crowd, making an appeal for law and order.

MUST BE HANGED DESPITE APPEAL

Johnson's Efforts to Fasten Miss Allison's Death on Another Are Futile.

MOUNT HOLLY, N. J., Feb. 20.—Eugus Johnson, the confessed murderer of Miss Allison, will be hanged on Friday, Feb. 23. No stay will be applied for. This course was decided upon by Prosecutor Atkinson and the court after conferring with Jacob C. Hendrickson, the condemned man's counsel, and taking proper steps to make Johnson's statements and charges against George Small legal evidence against him should he be tried later for murder.

Last evening Prosecutor Atkinson visited the condemned man, who was brought face to face with Small. In the presence of his counsel and disinterested witnesses Johnson again charged Small with the actual murder of Miss Allison. Johnson was very calm and self-possessed, while Small was highly excited and seemed in great fear. The condemned man stated that he knew he would soon die and wanted to tell the whole truth about the murder in order to save his soul.

Ex-Speaker Henderson Dying. DUBUQUE, Ia., Feb. 20.—Gen. David B. Henderson, formerly speaker of the National House of Representatives, has suffered another paralytic stroke, which has almost deprived him of his sight. His wife is the only person he recognizes. His general condition is worse. It is believed his end is near.

RACE SUICIDE IS TOO WELL VETOED

Washington Heights Nursery Swamped with Babies and Will Have to Close.

If the Pied Piper of Hamelin happens to be out of a job and had like to interest himself in another baby problem, his attention is respectfully called to Washington Heights. Anything approaching the increase in the infant population of that section is yet to be heard of. Even Mr. Roosevelt himself would be appalled. Babies do not come along in any ordinary or orderly abundance. They happen if you do not believe it just ask the Washington Heights Day Nursery.

The Day Nursery is a modest institution that was opened in 1902 by a few charitably inclined women of that neighborhood, who believed they could bear the expense of the whole enterprise. They desired to furnish a place where working mothers could leave their children while they earned their daily wage, and from the first the nursery was a great success. Five cents was charged to take any stigma of charity from the work.

During the first year 72 babies were cared for. In 1903 the number jumped to 1,162, and in 1904 it took another glacial leap upward, bringing the returns to 2,471. The Nursery managers were staggered, but still made heroic efforts to keep pace with the growing demand. But, when last year they were forced to shelter 12,000 babies, they threw up their hands.
