

WALL STREET.

FRIDAY, April 6.
Four large banking institutions put out about \$5,000,000 in call loans this morning at 25 per cent. A few loans were made for special reasons at 20 per cent. and some as high as 30 per cent., but as a general thing the rate was held strictly at 25 per cent. A market that at first gave signs of buoyancy and strength was depressed by this tightness in money. The fact that most of the borrowers had to be carried over until Monday aggravated the situation. Some brokers entered into special arrangements with their regular banks, Russell Sage and other large individual lenders, by which they obtained prompt accommodations, leaving the rate to be fixed later in the day. Kuhn, Loeb & Co. and the National City Bank loaned very freely at 25 per cent., and subsequently accommodated borrowers when the rate mounted to 27 and higher.

This abnormal advance in the rate for call money is but the natural result of a steady drain from the interior on the New York banks' supply of cash. Many of the interior national banks are making unusual drafts upon their New York correspondents in order to make as good a showing as possible in their April statements. A bad bank statement is expected here to-morrow, but the local banks are consoling themselves with the belief that monetary conditions will improve next week.

Traders long on wheat took profits rather freely in the early dealings today, but the market showed resistance owing to evidence of a demand at spot wheat centres. Prices started slightly lower, but subsequently rallied steadily with trading quiet.
