On Saturday our champions took the count with grace and ease, but yesterday Redland got a smart slap on the wrist for its impudence. But that isn't what we started out to remark.


We came out here awful cocky and expected the other Eastern teams to put a crimp in the pace being set by Chicago, St. Louis and St. Paul.
