

WORLD'S RECORD MADE AT BELMONT PARK

CRUISER BROOKLYN IS SAFE AT HAVANA, STORM KILLED 100

United States Warship Was Driven Ashore, but Is Reported to Have Been Floated Safely—Rest of Fleet Escaped Injury.

HAVANA, Cuba, Oct. 19.—More than 100 persons are reported killed in this city alone in the tornado that swept over western Cuba Tuesday night.

The cruiser Brooklyn was torn from her anchorage in the harbor and thrown up on shore, but was floated without sustaining any damage.

No fatalities are reported in the United States fleet, comprising the Minneapolis, Texas, Denver and Prairie, but all the vessels were menaced.

The loss of life in the interior must be heavy. Telephone and telegraph wires are down and the roads are impassable. The area covered by the storm was wide.

So far as is known most of the killed are natives. The camp of the United States marines was demolished and the tents were torn to ribbons.

MATHOT GETS SUBPOENA FOR DR. PARKHURST

Must Appear Before Magistrate Mayo in Police Court on Oct. 24.

BINGHAM WON'T TALK.

Commissioner Also Tells Deputy Mathot to "Shut Up and Say Nothing."

Third Deputy Police Commissioner Mathot appeared in Jefferson Market Court today and asked Magistrate Mayo for a subpoena summoning Dr. Parkhurst to appear in that court on Oct. 24. The subpoena was issued and given to a court officer for service.

The court Commissioner Mathot said nothing about his object in calling Dr. Parkhurst to the police court, but it is supposed to have some connection with the open letter to the Mayor sent by Dr. Parkhurst last week in which the accusation is made that New York is a sink hole of iniquity and that Commissioner Bingham is incompetent.

There was no attempt on the part of Commissioner Mathot to preserve any secrecy about his mission. When pressed to tell why Dr. Parkhurst should be compelled to go into a police court he referred his inquiries to Commissioner Bingham.

In the meantime Commissioner Bingham had held his regular session with the headquarters reporters and refused to hold another. When an attempt was made to see him he sent out word that he had nothing to say.

Deputy Commissioner Mathot was willing to tell all he knew about the matter, but he sent his secretary to Commissioner Bingham asking the necessary permission. The secretary returned with this message:

"The bosses order to you are to shut up and say nothing."

In his open letter Dr. Parkhurst made specific charges about conditions in the Tenderloin. Tenderloin police cases are handled in Jefferson Market Police Court, and the fact that Dr. Parkhurst is to be examined or questioned there indicates that he will be asked to tell what he knows about the conditions he so graphically described.

The trial of Inspector Schmittberger will be assumed to occur on Monday at 11 o'clock. At the last session Martin W. Littleton, Schmittberger's counsel, threatened to serve a warrant upon Policeman Faubel, one of the inspector's accusers, should he be produced again as a witness.

Faubel was on his vacation at that time. He is back now on duty at Headquarters, and may go on the witness stand to-morrow, when it will be up to Mr. Littleton to make good.

Dr. Parkhurst when seen at his home in the Tenderloin, was of the opinion that he had not the remotest idea why a subpoena had been issued against him.

"It is quite possible," he remarked, "that my letter charging the Commissioner with responsibility for existing conditions may have prompted this action. I will be here to accept service if it is ever lawfully served upon me."

COMPTROLLER CLOSES BANK IN WASHINGTON.

WASHINGTON, Oct. 19.—The Aetna Building and Trust Company (branch) of Washington, D. C., has been closed by direction of the Acting Comptroller of the Currency, and Robert Lyons appointed receiver. This company is a branch of the Aetna Banking and Trust Company of Butte, Mont., incorporated under the laws of West Virginia, and, with other banking companies organized by virtue of the laws of any of the States and doing business in the District of Columbia, was placed under the supervision of the Comptroller of the Currency by an act of Congress passed at the last session.

An examination of the bank by a national bank examiner shows the branch to be insolvent. The assets and liabilities, according to the last statement, are \$112,945. Among the assets are \$88,000 in bonds, securities, claims, etc. The branch had \$12,778 in savings and \$28,888 in individual deposits and was liable to the head office at Butte for \$10,397.

DRIVER BEHEADED BY HIS OWN WAGON

A man, not yet identified, was run over and beheaded to-day by his own wagon at Fifteenth avenue and Fifty-fourth street, Brooklyn. He was driving a two-horse wagon belonging to F. W. Johns, dealer in building materials, Harvey avenue, Brooklyn, and it was loaded with barrels of lime. While crossing Fifty-fourth street on Seventh-teenth avenue, the wagon was jolted, a barrel knocked the driver from the seat and he fell in front of the wheels, to which he passed over his neck, severing the head.

The horse continued for a half block before it stopped. The body was taken to the morgue.

AERONAUT THROWN FROM A BALLOON.

ALLIANCE, O., Oct. 19.—Harry Jewell, of Philadelphia, Pa., was perhaps fatally injured here to-day while attempting a balloon ascension. As the balloon arose it drifted against the corner of a building, the shock throwing Jewell out.

W. A. CHANLER GIVES THE LIE TO MURPHY

William Astor Chanler was seen this afternoon at the Knickerbocker Club in regard to the allegations that he had given Charles F. Murphy information on which he based the charge that the Independence League asked pay for Tammany in-borsements.

"I never have seen Mr. Murphy in connection with any of these reports," said Mr. Chanler with a show of indignation.

"I have absolutely no knowledge of any such transaction and was never, of course, a party to any such dealings as are alleged."

"I have not been under subpoena to appear before the Grand Jury in connection with the inquiry, nor have I been before the Grand Jury."

BISHOP POTTER'S DAUGHTER A SUICIDE

Mrs. Cowdin, Victim of Nervous Prostration, Eludes Nurse and Hangs Herself in Cellar.

CROMWELL, Conn., Oct. 19.—Mrs. Laura Potter Cowdin, daughter of Bishop Henry C. Potter, of New York, committed suicide Tuesday night at the private sanitarium here, where she was a patient. She hanged herself from a beam in a cellar with a rope made of twisted bed-clothes.

The sanitarium where the suicide took place is managed by Dr. W. B. Hallock and son. It is an expensive and exclusive establishment for the treatment largely of nervous diseases. Mrs. Cowdin, who suffered from nervous prostration, came here some weeks ago to put herself in the hands of Dr. Hallock. She had rooms at a private residence on the grounds of the sanitarium.

One of two nurses was constantly with her until Tuesday evening, when she eluded the nurse on duty and disappeared. Search for her went on some time before she was found hanging in the cellar of the house. She had been dead for nearly an hour.

Until to-day it was not known generally that Mrs. Cowdin had killed herself. On Wednesday, when the news of the death was announced, it was stated that she had died of natural causes. The truth came out when the body was shipped to Mount Kisco, N. Y., for burial. The certificate on the oasket gave the cause of death as suicide. An investigation was made by newspaper men and some of the facts came out. It developed that the Coroner of the county had held a private inquest.

Even yet the authorities of the sanitarium are making every effort to suppress the details of Mrs. Cowdin's death. All information is refused. It was by roundabout methods that the investigators learned that hanging had been the mode of suicide.

The body was buried to-day at Mount Kisco, where the services of St. Mark's Church. It is said the coffin was not opened after it left Cromwell.

Mrs. Cowdin was the second of Bishop Potter's four children by his first wife. She was forty-four years old. Her husband, Winthrop Cowdin, survives her. Their home in New York was at Eleventh street and Fifth avenue.

Mrs. Cowdin, it is said, used a trunk rope, which she needed and threw over a beam, and standing on a box, tightened the noose about her neck, kicked the box from under her and strangled herself.

The death certificate gives her age as forty-four years.

CHANLER SAYS HE HAS GIVEN \$5,000 TO EACH PARTY FUND.

SARATOGA, N. Y., Oct. 19.—Lewis Stuyvesant Chanler, Democratic and Independence League candidate for Lieutenant-Governor, said to-day regarding the report that he and his brother contributed largely to the Independence League and Democratic campaign fund: "I am glad of this opportunity to make another cheap campaign lie to the counter. I was not asked by any one directly or indirectly for any promise, subscription or pledge before I received the nomination from the Independence League or Democratic party."

"Last week I sent a check for \$5,000 to the Treasurer of the League, and a check for the same amount to the Treasurer of the Democratic State Committee. That is all that I or any one acting for me has subscribed directly or indirectly to any person or party. I ask that Mr. Jerome subpoena me to appear before the Grand Jury that I may state the truth under oath. I will accept the service of the subpoena by telephone and go to New York at once."

MURPHY NAMES MEN WHO TOLD ABOUT GRAFT

Tells Grand Jury W. A. Chanler Accused Independence League.

NO EVIDENCE HIMSELF.

Murphy's Examination Short and Then More Witnesses Are Called.

Charles F. Murphy furnished the Grand Jury to-day with the names of the men who gave him the information upon which he based the charge he made yesterday that representatives of the Independence League were grafting upon Tammany candidates.

He admitted that he had no evidence to substantiate the charge that Judge Otto Rosky's endorsement by the Independence League had been purchased. William Astor Chanler and Tammany Leader Joseph Pendergast, who is also Secretary to the Board of Water Supply, were the men named by Mr. Murphy as his informants concerning the alleged grafting tactics of certain Independence Leaguers. Subpoenas were immediately issued commanding them to appear before the Grand Jury and give evidence to substantiate their charges.

Mr. Pendergast was the first to answer the subpoena. He reached the Criminal Courts Building at the Grand Jury was about to adjourn on Tuesday, when Mr. Chanler will be heard.

"It is true," said Mr. Pendergast, "that I gave Mr. Murphy information upon which he based some of the charges he made. I will tell all I know to the Grand Jury, and until the facts come out through that body I have nothing further to say."

District Attorney Jerome is considerably interested in the Murphy charges and will take personal charge of the investigation which will grow out of the Grand Jury proceedings on Tuesday. At the conclusion of to-day's session of the Grand Jury Mr. Jerome went to Lakewood, Conn.

Mr. Murphy's examination occupied thirteen minutes. When he went into the Grand Jury room he was sworn by Foreman Fred J. District Attorney Jerome told him he was credited with some \$100,000 in the name of a newspaper reporter at Tammany Hall yesterday that he had heard of instances of men either paying the Independence League for nominations or being forced to pay. Independence League assistants asked them to withdraw.

Mr. Murphy replied that he had been correctly quoted in the newspapers.

"Mr. Murphy," said the District Attorney, "kindly tell the Grand Jury all you know about this matter. Give us the names of the men who gave you the information so that we may send for them."

Mr. Murphy then gave the names of Mr. Chanler and Mr. Pendergast. District Attorney Jerome then asked him if he could give the Grand Jury any information concerning his own charges that money had been paid for Independence League judicial endorsements. Mr. Murphy replied that he did not mean to be understood as having any information along that line concerning judicial candidates.

The foreman of the Grand Jury asked him if he did not think he had made a reckless statement about a judge on Tuesday.

BISHOP O'CONNOR BARS TWO SONGS

"Nearer, My God, to Thee," and "Lead, Kindly Light," Not to Be Used.

NEWARK, Oct. 19.—The Right Rev. John O'Connor, Bishop of the Catholic diocese of Newark, has issued an order to the various churches throughout the diocese putting a stop to the singing of "Nearer, My God, to Thee" and "Lead, Kindly Light" in the churches. The latter song may be sung after service, however, if the pastor sees fit to allow it, but under no circumstances is the first named song to be heard in the Catholic Churches under Bishop O'Connor's jurisdiction.

When seen at the Episcopal residence in South Orange to-day, the Bishop said that the rule of the church forbids the singing of anything that is not a part of the liturgical service, and insisted that "Nearer, My God, to Thee" was no more a part of it than "In the Sweet Bye-and-Bye."

The Bishop said that the hymn is purely sentimental and he can see no reason for its rendition. He said that "Lead, Kindly Light" is an appeal for spiritual light and there was no cause for singling it to the services. The latter hymn was written by Cardinal Newman before his conversion to Catholicism. The liturgical service is in Latin, but the singing of an English translation of a part of the Mass or of the Mass itself is not allowed in the Catholic Church not to allow songs not included in music regarding the appointment of the proper authorities. The two hymns have been sung frequently of late.

BOY OF ELEVEN KIDNAPPED FROM PUBLIC SCHOOL

Called Out on Wednesday by Mysterious Letter, He Disappears.

Central office detectives are asking the police of the East One Hundred and Twenty-sixth street station in attempting to locate eleven-year-old Raymond Maher, who was lured from School No. 56 Wednesday afternoon and kidnapped.

The only clue to what occurred to him after he left the schoolroom is embodied in a note received yesterday by the mother reading: "Have been kidnapped. Am all right. Raymond."

The boy is the son of Mr. and Mrs. Thomas Maher, of 221 East One Hundred and Nineteenth street. He commences work for the American Ice Company on Wednesday afternoon and collector for the American Ice Company at East One Hundred and Twenty-fifth street.

Raymond did not associate with any of his classmates of class 5B. He is the youngest of five children and will be twelve years old next Tuesday. He was confirmed last June.

WORKMAN KILLED BY FALL. Leo Archeal, thirty-five years old, living at Second avenue and Twenty-eighth street, while working to-day on a scaffold on the tenth floor of a building at First avenue and Thirty-ninth street, fell to the ninth floor and was killed.

EXPECT ROSEBEN TO BEAT RECORD OF SALVATOR

Speedy Gelding Will Try for New Mile Figures To-morrow.

Roseben, the peerless sprinter, is to be featured for his efforts to improve the world's record to-morrow even if he does not go the distance in better than 1:31 1-2. The Westchester Racing Association decided to-day to present the owner of the big gelding with a silver souvenir if he goes the distance under 1:31 1-2.

Roseben will begin his race against time immediately after the second race, and if he succeeds in lowering the world's record Harry Johnson, his owner, will receive a purse of \$5,000 and a gold cup.

Among horsemen it is generally believed that the record will be lowered. It is understood that Johnson will make a private purchase of one of his horses breaking the world's record, when Roseben broke the seven furlong record Johnson won \$10,000 which he had placed at even money.
