

FOOD THAT CABIN PASSENGERS GOT CAUSES PROTEST

Prominent People on the President Lincoln Say They Were Outrageously Treated.

PURSER IS THREATENED.

Army Officer Complains Because Request to Cash His Check Was Denied.

The Hamburg-American liner President Lincoln reached port today, bringing 120 of the most discontented first-class passengers that have landed in New York in a long time.

They had all signed their names to a statement which declared that the food which was furnished them on shipboard was unsatisfactory, and several of the passengers made charges of insubordination against the ship's purser.

Four of the passengers made up a committee which had protested to the captain about the fare. The members of the committee were Henry W. Baker, an importer, of No. 76 Franklin street; Henry M. Landgraff, of No. 218 East Eighteenth street; D. E. Dalham, of Philadelphia, and Major Charles Bernou, of the United States Army. They said today that on the third day out of Hamburg the luncheon served to the first cabin passengers consisted of tasteless soup, a dish called "farmers' hash," that was composed of scrambled eggs and potatoes, boiled soup, meat, cheese and coffee.
