REPUBLICANS NOW READY TO ACCEPT THE FUSION TICKET

Koenig Talks Over Long Distance Phone With Whitman and Atmosphere Clears.

TO GET MORE OFFICES.

Whitman Will Be Home Tomorrow and Will Make His Views Known.

As a result of a long distance telephone conversation between District-Attorney Whitman at Bretton Woods, N. H., and County Chairman Samuel S. Koenig to-day the heavy political atmosphere cleared enough to let it be known that the disunited Republican organization will accept Mr. Mitchell as its Mayoralty candidate if Mr. Whitman says so. A statement from the District-Attorney was expected tonight. Mr. Koenig's communication with Mr. Whitman took place in Acting District Wasservogel's office in the Criminal Courts building. It was not until Mr. Wasservogel had assured his chief that Mr. Koenig was in his office that the District-Attorney consented to speak. "What was said between Mr. Whitman and Mr. Koenig and between the District-Attorney and his aide was not disclosed, but Mr. Wasservogel said after the talk:

"The District-Attorney will leave Bretton Woods late to-night and reach his office some time early to-morrow. I spoke to him on office matters."

KOENIG SAYS IT'S UP TO MR. WHITMAN.

Mr. Koenig was asked to state the nature of his conversation with Mr. Whitman.

"I can only say that everything is up to the District-Attorney," he replied. "He will be here to-morrow to speak for himself. Until that time there is nothing to be said."

From other sources it was learned that Mr. Whitman, although disappointed and still mindful and appreciative of the loyalty of his friends, is prepared to accept the nomination for the office of District-Attorney.

Powerful leaders in the Republican party are said to have convinced the disgruntled Republicans that they will be better off in accepting what they term a bad bargain, than to run the District-Attorney on an independent ticket and face certain disaster. This argument was largely supported by assurances that the Republicans will have ample representation on the ticket for places for Supreme Court justices and possibly the Sheriff's office.

Much dissatisfaction among Republicans as to the Fusion slate has developed. It was made plain to-day that the security of the Fusion ticket is by no means a certainty.

STORY CIRCULATED TO SHOW THERE IS DISCORD.

As an evidence of the discord and of efforts to demolish the Fusion slate leaders in the Republican party circulated the story to-day that Borough President McAneny had sent word to friends here from Lake George that he will not accept a nomination for the Presidency of the Board of Aldermen. The statement attributed to McAneny is as follows:

"I am not disposed to accept any nomination on a ticket which is headed by District-Attorney Whitman for the reason that I am a candidate for Mayor and nothing else, and I will not accept a place on any ticket which proposes Mr. Mitchell for Mayor as a matter of principle."

This statement was alleged to have been made by Mr. McAneny the night before the Fusion slate was announced. It was declared to-day to state Mr. McAneny's position now just as it did the night before the slate was given out. Although Mr. McAneny's friends have denied the statement, Republicans who insist that Mr. Whitman must be nominated declared to-day that there is no chance of getting Mr. McAneny to accept a place on the ticket below that of collector Mitchell and District-Attorney Whitman.

MITCHELL DECLARES HE DOES NOT BELIEVE IT.

Mr. Mitchell was seen in his office and asked if he had heard the statement attributed to Mr. McAneny.

WIFE FIGHTS FOR LIFE AS BROKER LAIMBEER, VICTIM OF AUTO, DIES

Mrs. William Laimbeer Does Not Know That S. Osgood Pell and Husband Were Killed by Train at Long Island Crossing.

GHOULS AT RAILROAD ROBBED BODY OF VICTIM

Witnesses Say Train and Headlight Were Easily Visible Before Fatal Machine Reached Track.

Mrs. William Laimbeer, the sole survivor of the four, in S. Osgood Pell's machine struck by a Long Island electric train a mile and a half west of Long Beach last night, is in such a serious condition in the Nassau Hotel at Long Beach, that the doctors in attendance do not dare to remove her to her home near Hempstead. Both of her leg were broken when the train struck the auto, her left arm and two of her ribs were fractured and the physicians fear that she suffered additional internal injuries. She has been kept under opiates since the accident and has had only fleeting periods of semi-consciousness.

Coroner Neu has ordered a preliminary inquest in the Town Hall at Lynbrook to-morrow at 10 o'clock.

ANTHONY N. BRADY LEFT \$70,000,000 TO HIS FAMILY

Will, Filed To-Day, Gives Widow \$1,000,000 and \$60,000 Annuity for Life.

ALBANY, Aug. 4.—The will of A. N. Brady was filed by a representative of Morgan J. O'Brien's office with the Surrogate here to-day, disposing of his estate, estimated at \$70,000,000.

Mr. Brady bequeaths to his wife all the furniture, silverware, books, pictures, horses, carriages, automobiles and all other personal property in or about his late residence in the city of Albany. He devises to his wife said dwelling house, together with other real property in Albany. He bequeaths to his wife an annuity of \$60,000 to be paid to her in equal quarterly-yearly payments during her life. In addition to the above Mrs. Brady receives the sum of \$1,000,000.

The residuary estate is divided into six equal parts. One part is bequeathed to his son, Nicholas Frederick Brady, one part to his son, James Coxe Brady, three parts are given to the executors and trustees, to be held for the benefit of the testator's three daughters, Margaret Ruth Brady Farrell, Mabel Brady Garvan and Marcia Myers Brady Tucker, and the remaining part the testator gives to his executors and trustees to be held for the benefit of his granddaughter, Marcia Ann Gayt.

The executors and trustees are Nicholas Frederick Brady, James Coxe Brady and the Central Trust Company of New York.

The will was made in January, 1912. There are bequests to local institutions and three annuities of \$1,000 each to Mrs. C. B. Stinson, Mrs. A. L. Farr and Mrs. F. L. Burton.
