"POSSUM HUNTERS" CALLED TO TRIAL; EVERYBODY ARMED

Prisoners, Members of Kentucky Secret Order, Are All Guarded—Witnesses, Too.

HARTFORD, Ky., Aug. 25.—Ohio county was armed to-day. Citizens directly or indirectly connected with the trial of alleged members of the "Possum Hunters" organization, scheduled to go on trial here to-day, were taking no chances. From early morning backboards and horses and wagons kept pouring men who are walking armaments into Hartford to attend the trial.

Officials were taking precautions against trouble. The "Possum Hunters," who operate on the Ku Klux Klan style, have powerful friends,

and no chance were being taken of a possible delivery.

At Courtrooms in a "garage." On the third floor of a brick building surrounded by guards armed with Winchester, four alleged members of the midnight fogging party were waiting to be called to court.

In another building were twenty witnesses, all armed and guarded from attack. The men had promised to turn State's evidence and in the past few days notices threatening death to them if they testified have been posted on the doors of their homes.

Court officials and attaches have also been threatened.

The first of the prisoners to be tried are those charged with fogging Stephen Howard and his wife. Two of the "Possum Hunters" confessed to-day that they had been part of the gang that terrorized this section of Kentucky. They are Jere Clark and his son-in-law, Edward Timmons. They were sentenced to serve two years in the penitentiary. Both said they were driven to their acts by the Consolidated Tobacco Growers' Association. Their confessions are said to have incriminated others of the alleged gang.

BANGOR LOOKS GOOD TO RUNAWAY MISS, 13, DESPITE BOY "TEASES"

Helen Bryer Willing to Go Back Without Shedding Her Simple Ways.

In the rooms of the Children's Society to-day Helen Bryer, a quaint little miss of thirteen, said she had run away from her home to Bangor, Me., and come to New York because the boys in Bangor teased her about her simple ways.

"I just wanted to know how the great ladies act," she said. "New York is full of great ladies. I was told that they have fine positions here and that some of them earn as much as \$10 a week. You know Bangor isn't as exciting as New York, but I kind of like Bangor and I want to go back as soon as I can."

"Eight days ago I ran away from home with \$25 belonging to dad and went to Boston. I stayed at the Y. W. C. A. there and had a fine time seeing the city. Then I got homesick and went back to Bangor. But the boys there kept teasing me about being simple and so I thought I'd go to New York."

"This time I took \$25 from dad and sneaked away from home Friday night. I sat up in the depot and took

a morning train to Lincoln, Me., where I saw some girl friends and spent most of what I had. Then I bought a ticket for New York, and when I got here Monday I had only 25 cents.

"A negro man in a uniform took me to a nice place near the alligator (the museum situated) road and he was respectful because I told I had come here to be a great lady. Then I rode on the alligator train till my fifty cents was gone, when I went to a police station."

Helen displayed rare shrewdness in going straight to the police when her funds gave out. She entered the Greenwich Street Station last evening, told her story and was turned over to the Children's Society, while word was sent to her parents, who live at No. 124 Lincoln Avenue, Bangor.

"I don't want to run away again," sobbed the child as she put on a little black poke bonnet with green ribbons, and started for the Children's Court. "New York is too big and too noisy for me."

KINKEAD INVENTS NEW METHOD OF SILENCING HECKLER; ARRESTS HIM

When Speech Ends Picturesque Sheriff Frees His Political Opponent.

KEARNY, N. J., Aug. 25.—Sheriff Eugene F. Kinkead, whose picturesque handling of the oil strikers at Bayonne brought him great publicity, is handling the political fight in Hudson County along much the same lines. He came here last night to speak at a rally of the Kearny Democratic Association. Kinkead is seeking to get the county leadership, as against Port Warden Otto Wittgen.

Dennis Dunn, a local Wittpen leader, who is seeking nomination by the Wittpen faction for member of Assembly, was at the meeting. While Kinkead was speaking, Dunn asked questions about the Bayonne strike.

"I don't want to try to explain things now," the Sheriff replied. Dunn replied, and after a further interchange of words, the Sheriff shouted:

"Dunn, you're no gentleman."

"Kinkead, you can go to hell," Dunn replied.

Kinkead started toward Dunn, buttoning his coat. Friends prevented the men getting together, and then the Sheriff, pointing at Mr. Dunn, exclaimed:

"Dunn, as Sheriff of Hudson County, I place you under arrest. Sit down and keep still."

Then followed an impassioned tirade against the Wittpen faction and when he closed the Sheriff announced that he removed the arrest from Mr. Dunn, who had sat quietly through the speech, once the arrest had been made.

The association passed a resolution endorsing the Sheriff and specifically his work at Bayonne.

AMELIA BINGHAM TO RETURN.
