

CITY ITEMS.

THE OPERA AT NIBLO'S.—In noticing the performance of the Daughter of the Regiment on Monday evening, we ascribed to Mr. Hudson the praises of *Spicchio* which were due to Mr. Leach. Mr. Hudson, of course, was the Tenor of the Opera.

THE RIVER IS NOW FAIRLY OPEN, and several boats are running. The Hendrik Hudson and Isaac Newton are at work, and the Empire, Troy, and Oregon are ready. The five boats (forming the People's Line) have been thoroughly repaired and newly furnished, for the comfort and luxury of travelers, and will doubtless have a large share of custom. The day line is not yet started, and in this we fear the public will miss their two favorites, the Reindeer and Capt. DeGroot. However, there will be no lack of capital accommodations for all who prefer the river to the rail. We notice that opposition has been made already, the Manhattan having left on Monday night at 50 cents fare.

THE PRESIDENTS OF THE ATLANTIC MUTUAL, General Mutual, Mercantile Mutual, San Mutual, Aster Mutual, and Union Mutual Insurance Companies, each accompanied by a representative, on Monday, William J. Murphy with \$25, to relieve the distresses of Josiah G. Kelly, Frederick Colby, and the widow of Isaiah D. Phillips, master, mate and cook of the unfortunate schooner Reaper, of Yarmouth, Mass., which vessel foundered off Montauk on Thursday last, the survivors having been rescued by the Pilots and crew of the pilot boat Yankee only by the most arduous exertions.

OMNIBUS DRIVERS' MEETING.—There was a meeting of the Omnibus Drivers' Benevolent Association held on the evening of the 29th inst., at Masonic Hall, No. 600 Broadway, attended by about three hundred drivers. Resolutions were passed directing Trustees to apply to Mayor and Aldermen for leave to put twenty Omnibuses on some route hereafter to be determined, and organizing a Joint Stock Company, the price of shares to be \$10, and 500 shares were taken up on the spot.

THE EXPLOSION AT HELL-GATE.—The testimony before the Coroner in regard to this catastrophe does not develop any new facts. The Jury attached no blame to any one, except a pilot who when requested to go to the assistance of the wounded persons, refused, saying: "They should have been blown to hell long ago." Of course no ship owner or Captain will ever again employ such a heartless wretch.

UNION PRAYER MEETING.—Some of our readers may not know that such a meeting is held every morning, at 8 o'clock, in the Central Presbyterian Church, Broome-st. The attendance, which is large and respectable, is continually increasing. On Monday morning there were about a thousand persons present.

A bargain has just been closed, on behalf of some English capitalists, for certain lots on 25th, 26th, 29th, and 30th sts, and a portion of the Harlem Railroad property, in all amounting to the sum of \$250,000. This is an advance of \$50,000 on the cost of the same property only two years since.
