They find they were mistaken. The Republicans are not guilty of the silly stupidity which the Soft leaders reckoned on. They will improve this great opportunity.

They have nominated not an old man, but one in the full vigor of life; one trained to business and familiar with public affairs; a man against whom

paying a Quarter of a Million more per annum for her Common Schools than she ought to pay for much better ones. The right sort of School officers can save that Quarter of a Million—not all, perhaps, the first year, but they can BEGIN to save it forthwith, and keep on till it is done. Be sure to vote for School Officers, and to vote for the best candidates who have a chance to be elected!

Never, in any Municipal election, have we known such animation as now pervades the city. The great Republican meeting of Thursday night was but the center of a series of similar demonstrations in a majority of the Wards of the city. At all of them the same confidence, the same high enthusiasm, the same unflinching steadiness of purpose, were manifested. In these great demonstrations we had a cheering assurance of the Vital Hold which Republican principles have upon the members of the party.

And now, Friends! To work! A whole day is before us, in which to confirm our forces, fully array our strength, and make entirely ready for the glorious victory which is within our grasp to-morrow. And let it be borne in mind that it is a victory for which good men of all other parties will owe us a debt of gratitude.

Let us have New-York from the danger of Fernando Wood; let us snatch it from the vultures of Tammany Hall; and there is no tax-payer, there is no honest citizen of any school of politics, who, after the election is over and the excited feelings of partisanship have become calmed, who will not say that we have done well.

Therefore, let not only every Republican, but every independent taxpayer, who is not restrained by engagements that cannot be escaped, give this day and to-morrow to the public service. There is no occasion for more meetings; it is the quiet, noiseless effort that now is wanted. A good indication of what is to be expected from the election of the Tammany candidate for Mayor may be found in the men running on the same ticket for Aldermen and Councilmen in various parts of the City. In the 11th District we have, among Mr. Havemeyer's friends, Mr. G. P. Bickford, candidate for Alderman, a gentleman now under indictment for illegally disposing of the property of the city.

In the 12th District, Mr. M. Tuomey, also a candidate for Alderman, labors under the same little inconvenience. In the 13th District, Mr. F. I. A. Boole, also a seeker after Aldermanic honors on the Havemeyer ticket, is similarly under indictment; while, superior even to them all, in the 17th District, is Mr. Terence Farley, the favorite of the Havemeyer men of that region, now under indictment for fraud committed with that great crop of frauds in the Street Department which our Havemeyer District-Attorney seems not disposed to bring to trial.

Coming down town, and looking about among the Tammany candidates for Councilmen, we find Mr. McCarty of the 14th District under indictment for murder, and conventionally out of prison on \$3,000 bail. In the 15th District Wm. H. Bulter, and in the 16th J. Van Tine, are both under indictment for illegal disposition of the city's property.

Mr. E. Costello, another Tammany candidate in the 17th District, is not under indictment, but has the accomplishment of not being able to read and write; while in the 18th District the Havemeyer men are called to support for Councilman Mr. C. H. Campbell, a party in the brutal and murderous assault lately committed on Mr. Thompson of The Daily News.

—Men of New-York! Is this a party which you desire to keep in power over you? If Yes, vote for Havemeyer. If No, vote for Opdyke.

The Express says that the Americans, in Convention have nominated Mr. Havemeyer. This is not the truth, as may be seen by reference to the address of the American Committee, in another column. The American Convention, by means of an intrigue, first nominated Mr. Ogden on Friday night, Nov. 25, the Convention adjourned over to Monday night, Nov. 28. At the adjourned meeting an animated and prolonged discussion took place, and the Convention arrived at the conclusion that by retaining Ogden in the field they were only helping to elect Fernando Wood. Thereupon they reconsidered the nomination of Ogden, laid it on the table, and, by a large majority, nominated Opdyke. At this a body of those who had most zealously resisted the withdrawal of Ogden, and who were in the minority on the final vote nominating Opdyke, bolted, and got up a bogus Convention, at which they nominated Havemeyer. These are the simple facts. Opdyke is the regular candidate of the Americans, regularly nominated by their City Convention.

Whether the object of the bolters really is to elect Fernando Wood by drawing off votes from Opdyke, is something which they know better than we
