WHAT WILL HE DO WITH IT?

The Governor hears both sides of the High-License question.

Two hours of argument for and against the Crosby bill—Mr. Hill listens, says nothing and withdraws—Democrats make strong pleas.

Albany, May 3.—If Governor Hill does not sign the High License bill from the evidence that he heard to-day he is neither the good lawyer that he is reputed to be nor the shrewd and wily politician that all who know him have reason to believe that he is.

The liquor men were out in force and nearly filled the Chamber. They came in large delegations from all over the State and evidently expected by the force of numbers alone to overcome the arguments which would be presented in favor of the bill.

On the other hand, the friends of the measure, although fewer in number, more than made that up in appearance and the way in which they presented their side of the matter.

The opponents were Lawyer Fanning, counsel for the liquor dealers; Max Stern, president of the Retail Liquor Dealers' Association; and "Jimmy" Oliver, the notorious Paradise Park statesman.

The Governor stated that he would allow an hour to each side in which to present the argument for and against the measure, and that the opponents of the measure would speak first.

Max Stern followed with an appeal for the liquor dealers' business would be interfered with if this bill became a law.

"Jimmy" Oliver, seeing that the liquor dealers of New-York had all the support they needed, went up into the State and became a farmer.

The Personal Liberty League also had a representative present against the bill.

Colonel Watson, the well-known Democrat and lawyer of New-York, took the floor for the bill.

Up to this time not a muscle of the Governor's face had moved, except to announce the end of the hour and to choke off his friend "Jimmy" from Paradise Park.
