Last year the amount was \$8,440,530.25. The Board cut down the demands of the various departments \$1,137,000. The amount allowed for county expenses was \$1,907,250, making a grand total to be raised by taxation of \$10,975,101.20.

SOME OF THE PRINCIPAL ITEMS, as compared with last year's amounts, are these: Board of Education \$1,900,329.65; for 1889, \$1,559,983.93; City Works Department, for 1890, \$1,111,119.19; for 1889, \$1,339,752.12; interest on city debt, for 1890, \$1,548,200.07; for 1889, \$1,529,117.17; Police Department, for 1890, \$1,576,089.99; for 1889, \$1,518,937.72; Fire Department, for 1890, \$752,400; for 1889, \$747,650; Park Department, for 1890, \$800,000; for 1889, \$401,200. One item not included last year is \$100,000 for the purchase of sites for buildings needed for city purposes.
