

TAMMANY A DEAD WEIGHT.

BLIGHTING INFLUENCE OF THE ORGANIZATION IN ULSTER COUNTY.

COUNTRY DEMOCRATS SICK OF CARRYING THE LOAD IMPOSED ON THEM BY HILL-JACOB RICE'S DISGRACEFUL AFFILIATIONS AT ALBANY.

(BY TELEGRAPH TO THE TRIBUNE.)

Kingston, N. Y., Oct. 29.—One of the consequences of the acquisition by Tammany Hall of the control of the organization of the Democratic party in this State has been the bringing forward of Democratic candidates of the Tammany Hall type. William F. Sheehan had a little Tammany Hall in Buffalo and Edward Murphy, Jr., another in Troy, and Democrats were nominated for the Legislature by them who could not be distinguished when they arrived in Albany from the Democratic Senators and Assemblymen from New-York City. This lowering of the standard of Democratic members of the Legislature extended in time even to rural counties, and men were astonished to see Senators and Assemblymen representing honest Democrats who were acting in alliance constantly with Tammany Hall and bringing disgrace upon the Democratic party.

Thus, two years ago the Senate district of which this county of Ulster forms a part elected Jacob Rice as its Senator. Rice had been an Assemblyman from Ulster County for several years, and had been the intimate companion of "Tim" Sullivan, "Sam" Foley and other faithful members of Tammany Hall. Not only was he the companion of Sullivan, but he acted with him in most legislative matters. He might just as well have been elected from the Five Points of New-York as from Kingston. Even politicians were therefore amazed when David B. Hill forced him upon this Senate district, turning down Clarence W. Bloodgood, of Greene County, who had been a credit to the district and to the Democrats. It need not be said that Rice as State Senator has continued that friendship with "Tim" Sullivan and the other Tammany Hall Senators which was notable in his career as an Assemblyman.

David B. Hill, of course, has insisted upon Rice's renomination, but there are signs that the Democrats have been looking at Rice's legislative record, and are not so ready as they were two years ago to vote for him. The Senate district has been so changed that the Republican party's chances of carrying it have been largely increased. Two years ago one of the counties which gave David B. Hill a majority of the vote was Schoharie last fall, and the county is usually known here as the 200 Democratic majority. Its separation from the district, leaving Ulster and Greene together, has placed the Republicans more on a numerical equality with the Democrats.

In the case of the district was as follows: Harrison—Greene, 2,314; Ulster, 2,450; total, 4,764. Cleveland—Greene, 2,371; Ulster, 2,808; total, 5,179. Mr. Cleveland thus had 215 plurality in favor of the Democrats. The Republican party in the district was largely increased in its vote in 1894 as follows: Morrison—Greene, 3,853; Ulster, 3,848; total, 7,701. Hill—Greene, 4,731; Ulster, 8,284; total, 13,015. The Republican plurality in the district last fall, it is thus apparent, was 1,882. Of course, there is a Republican majority in the district, but it is not expected this fall, but the Republican leaders naturally think they can retain some of the plurality for their candidates of this year.

"I think we are going to carry the district," said Charles H. Davis, of Saugerties, a State Senator. Charles H. Davis, of Saugerties, said Sylvester B. Sharpe, the chairman of the Republican County Committee of Ulster County, today, and the political signs are certainly in favor of Mr. Davis. He is a prominent Republican town of Saugerties, where Republican feeling is intense. Mr. Davis is also personally a popular man, and is a strong and active campaigner. Nothing that he can honorably do to carry the district is beyond his power, and he will be neglected by him. The liquor dealers, it is reported, have thrown \$5,000 into the district to elect Rice. A big distribution of money in Rice's interest in Kingston, therefore, may be expected on Election Day.

The Republicans have renominated William S. Van Keuren and James Lounsbury, who so faithfully represented Ulster County last winter in the Assembly. The Republican party will have a splendid thing for furnishing a close, careful, exact and well-founded basis upon which to build an estimate of the result. ANTI-SEMITES WIN IN VIENNA. DR. LUIGER AGAIN ELECTED MAYOR—DISTURBANCES IN THE CITY.

Vienna, Oct. 29.—Herr Luiger, leader of the Anti-Semites, was elected Mayor of Vienna this morning by 30 votes to 44 in the Municipal Council.

At least 20,000 people were gathered around the Town Hall during the election, and when the result was announced it was received with shouts of joy. However, there were several disturbances in the streets and many of the rioters were arrested.

Dr. Luiger, who is the anti-Semitic leader in the Reichsrath, also won the Burgomaster of Vienna last May. Dr. Grubel, the Burgomaster, who is a Liberal, was opposed to Dr. Luiger, and when the latter was elected, Herr Grubel resigned the Burgomastership. Dr. Luiger refused to accept the office to which he was elected, basing his refusal on the fact that the majority he had received was the smallest that was permitted by law to elect. Upon learning of his refusal a mob made an attack on the Town Hall, which they stormed and looted. The rioters occupied the galleries and lustily cheered Dr. Luiger and hooted his opponents. Finally the military were called to restore order, which was done only after a fierce fight.

The capture of the Municipal Council by the Anti-Semites was treated as involving a great deal more than local politics. In fact, the ambassadors at Vienna notified their respective Governments of it as though it were of international importance. The victorious party is made up of a lot of restless elements, including Extreme Clericals, ultra-fundamentalists and all shades of the proletariat, including labor agitators and Socialists. The numerical and financial strength of the Hebrews in Vienna made hostility to them a most telling pretext in the campaign, and the vote to-day, giving Dr. Luiger a majority of 30 votes, was taken in large measure on that basis.

Upon learning of his refusal a mob made an attack on the Town Hall, which they stormed and looted. The rioters occupied the galleries and lustily cheered Dr. Luiger and hooted his opponents. Finally the military were called to restore order, which was done only after a fierce fight.

The capture of the Municipal Council by the Anti-Semites was treated as involving a great deal more than local politics. In fact, the ambassadors at Vienna notified their respective Governments of it as though it were of international importance. The victorious party is made up of a lot of restless elements, including Extreme Clericals, ultra-fundamentalists and all shades of the proletariat, including labor agitators and Socialists. The numerical and financial strength of the Hebrews in Vienna made hostility to them a most telling pretext in the campaign, and the vote to-day, giving Dr. Luiger a majority of 30 votes, was taken in large measure on that basis.

AN ALLEGED RUSSIAN DEWALY. THE LONDON EMBASSY DISCREDITS REPORTED CHINESE TREATIES.

NO EXCEPTIONAL RIGHTS AT PORT ARTHUR—WONG CHI CHUAN VISITED ST. PETERSBURG.—DOUBT CAST UPON RUSSIA'S REPORTED DOINGS IN THE EAST.

London, Oct. 29.—It is said at the Russian Embassy in this city that a telegram was received some days ago from Prince Lobanoff-Rostovsky, the Russian Foreign Minister, declaring that the report that a secret treaty had been negotiated between Russia and China was unfounded. Prince Lobanoff-Rostovsky, so far as the Embassy is aware, was to congratulate the Czar upon his accession to the throne. The Embassy knows nothing whatever of Wong Chi Chuan being the bearer of a secret treaty on that occasion, and is equally ignorant of any steps being taken by Russia to build a railway in Chinese territory.

REISS ARRESTED IN COLON. HE IS WANTED IN NEW-YORK FOR STEALING \$1,000 WORTH OF JEWELRY.

Colon, Colombia, Oct. 29.—The United States Consul here has arrested Joseph Reiss, who arrived here from New-York on board the steamer "Albatross," which left New-York October 27. The arrest was made upon the authority of a telegram from the Police Department of New-York, charging Reiss with grand larceny.

FIGHTING NEAR ALEPPO. A THREE DAYS' CONFLICT BETWEEN TURKS AND ARMENIANS.

Constantinople, Oct. 29.—Advices from Aleppo say there has been continuous fighting in Marash, ninety miles northwest of Aleppo, for the last three days between Turks and Armenians. No details of the disturbances are yet obtainable.

FRENCH GOVERNMENT TROUBLES. A TENTATIVE CABINET LIKELY WITH M. BOURGEOIS AS PREMIER—THE PRESS ON M. RIBOT'S FALL.

Paris, Oct. 29.—President Faure spent the whole day in consultation with leading politicians, including General Zurlinden and MM. Lebon, Poincaré and Legoux, of the Ribot Ministry. Problems involved in the budget were the chief matters of discussion. After the conference of the President with MM. Chaillemat-Laurat and Brisson, respectively president of the Senate and Chamber, it was presided by persons in positions enabling them to obtain the most reliable information that a tentative cabinet would be formed, with M. Bourgeois as Premier and Minister of the Interior, M. Peytral, Minister of Finance; M. Doumer, Minister of Commerce; M. Cavaignac, Minister of War; M. Berard, Minister of the Colonies; M. Guvot-Desaulniers, Minister of Justice, and M. Doumergue, Minister of Public Works.

THE KING'S SON AS COREAN MINISTER.

Washington, Oct. 29.—Pak'Yong Kiu, the Korean chargé d'affaires, has advised from his Government tending to confirm the called announcement from Seoul via St. Petersburg that a prince of the royal blood may come to America as Minister. He is inclined to recognize the Cuban rebels. He says that the United States have given and continue to give Spain proof of their friendship. He mentioned the tone of a section of the Spanish press in criticizing the Government at Washington. He attributes such criticism to the mistaken zeal of ultra-patriotic people.

FATAL COLLISION ON A FRENCH RAILWAY.

Paris, Oct. 29.—A passenger train from Paris to Toulouse, due at the latter place at 11 o'clock this forenoon, came into collision last evening between Lexas and La Gueule in the Department of Tarn-et-Garonne, with a train from Toulouse for the North. Both trains were wrecked, with passengers and crew killed. M. Jaurès, socialist deputy for Tarn, was a passenger on the southern-bound train on his way to Carmux. He was badly cut about the head, but is not expected to be seriously injured. About twenty were slightly injured.

THE ANTWERP DOCK TOLL REDUCED.

Antwerp, Oct. 29.—The Common Council at a meeting held last evening voted that ships entering the docks here after the beginning of the year 1896 shall pay to the city the sum of 50 centimes instead of 84 centimes, as heretofore. The Council also voted to suspend the practice of imposing an additional charge in cases where the navigation rights of vessels were different.

IS ENGLAND SEEKING A QUARREL? St. Petersburg, Oct. 29.—A dispatch to the "Novoye Vremya" from Vladivostok says that a British naval squadron has concentrated at Foo-Chow. The paper says that Great Britain is anxiously
